Pursuant to section 372 of the General Municipal Law and section 48-6 of the Town of Ossining Code, which provide that the Court shall designate the fines that the Traffic Violations Bureau shall imposed for guilty pleas to Town of Ossining parking offenses and to certain State Vehicle & Traffic Law offenses, the Court hereby designates those fines below, for 2015, upon conviction by guilty plea for each of the listed offenses, entered before the first court appearance.

<u>Offenses</u>	<u>Payable before First Court Appearance</u>
• Parking or standing prohibited at all times on certain listed highways (Town Code § 188-11)	\$30
• Parking from 3 am to 6 am, from November 1 to and including March 31 of each year, prohibited (Town Code § 188-10)	\$30
• Parking from 3 am to 6 am, year-round, prohibited in any designated public area within a municipally owned property (Town Code § 188-10)	\$30
• Parking prohibited for more than two hours per spot in any designated public area within a municipally owned property (Town Code § 188-10)	\$30
• On Street Handicapped Parking (VTL § 1203-b):	\$70 + \$30 = \$100

Offenses


Payable before First
Court Appearance

- Off Street Handicapped Parking [VTL § 1203-c(4)]: \$50 + \$30 = \$80
- Parked in Wrong Direction [VTL § 1203(c)]: \$30
- Parked by Fire Hydrant [VTL § 1202(b)(1)]: \$50 + \$25 = \$75
- Parked by Fire Station Driveway [VTL § 1202(a)(2)(d)]: \$50 + \$25 = \$75
- Parking/Stopping on Sidewalk [VTL § 1201(a)]: \$35 + \$25 = \$60
- Double Parking [VTL § 1202(a)(1)]: \$35 + \$25 = \$60
- Parked Blocking Driveway (VTL § 1202(a)(2)(a)]: \$35 + \$25 = \$60
- No Front License Plate [VTL § 402(1)(a)]: \$27 + \$93 = \$120
- No Vehicle Registration, Parked < 60 days [VTL § 401-1(a)]: \$47 + \$93 = \$140
- No Vehicle Registration, Parked > 60 days [VTL § 401-1(a)]: \$77 + \$93 = \$170
- No Inspection, Parked < 60 days [VTL § 306-b]: \$25
- No Inspection, Parked > 60 days [VTL § 306-b]: \$50
- Abandoned Vehicle [VTL 1224(7)]: \$257 + \$93 = 350
