Dear Chairman Hougham and Members of the Planning Board:

We are in receipt of the review memo from Dan Ciarcia, P.E., dated July 21, 2021, for the above referenced project. We offer the following responses.:

- 1. This has been included on the current Site Condition's Sheet.
- 2. We are unsure of the exact material and thickness of the current parking area. We have prepared an Amended Site Plan with specific details for the proposed parking area.
- 3. This is included on the Amended Site Plan.
- 4. Runoff will be managed in the same manner as the Approved Site Plan. It will be collected by catch basins and directed to a downstream defender unit before being discharged to subsurface chambers. A swale will direct runoff from the hillside away from these chambers. As such, the Approved SWPPP shall still be applicable in the design, operation, and maintenance of the system.
