##### **A. Personnel-Appointment-Acting Assessor**

**Councilmember Tawil moved and it was seconded by Councilmember Harter that the following be approved:**

**Resolved, that the Town Board of the Town of Ossining hereby appoints John McGrory, Pearl River, NY to the temporary position of Assessor effective May 4, 2011 at \$60.00/hr to replace the current Assessor who is currently on a medical leave.**

##### **B. Personnel- Assessment Clerk**
