##### **B.    Authorization to sign contract with NYS Department of State**

Whereas the Town Board of the Town of Ossining, in partnership with the Village of Ossining, applied for and received a NYS Department of State High Priority Planning Grant for \$45,000 to study possible alternate government structures for the two municipalities, and

Whereas the completion of the grant requires a signed contract between the Town of Ossining as the lead agency and the NYS Department of State, therefore be it

Resolved that the Town Supervisor is authorized to sign the grant contract, pending approval by the town attorney.

**C. Authorization to sign NWEAC Agreement for Energize! Program**
