## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN THAT a Public Hearing of the Town of Ossining Planning Board will be held on Wednesday, December 15, 2021 at 7:30 p.m. at which time all persons interested will be heard upon an application by Borrego Solar Systems Inc. in accordance with the code of the Town of Ossining, Chapter 200-50, Approval of Site Plans. The applicant proposes a minor amendment to the layout of a standalone energy storage system that would be used to supplement power to the local power grid at peak hours, by utilizing New York State's Value of Distributed Energy Resources (VDER) mechanism.
