NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN THAT a Public Hearing of the Town of Ossining Planning Board will be held on Wednesday, December 16, 2020 at 7:30 p.m. at which time all persons interested will be heard upon an application by Borrego Solar Systems Inc. in accordance with the code of the Town of Ossining, Chapter 200-50, Approval of Site Plans. The applicant proposes to construct a standalone energy storage system that would be used to supplement power to the local power grid at peak hours, by utilizing New York State's Value of Distributed Energy Resources (VDER) mechanism.

The property is owned by the Archdiocese of NY (St. Augustine Church Property) and is located at 381 North Highland Avenue, Ossining, NY within the unincorporated area of the Town of Ossining in the R-20 One-Family Residence Zoning District and constitutes land described on the Tax Map of the Town of Ossining as Section 81.18 Block 2 and Lot 1.
