Thanks for the reply. No one at Mystic had a copy of the easements and there was some confusion about the specific wording. As I may have mentioned, I obtained copies from the County Clerk with the help of a friend who is an attorney. The easement predates the construction of Mystic Pointe and is signed by the Chuch and a corporation that initially purchased the land for development.

Per my "lay" reading, there is nothing that impacts the energy storage proposal as long as the appropriate insurance is in force.

All interested parties, Borrego, the Church, and the Planning Board now have copies.

Good afternoon. Our legal team is tied up over the next week with end-of-year activities, but we're looking to pick this up in earnest prior to the next Ossining Planning Board meeting on 1/20. Our initial review didn't indicate that the easement, as written, includes any restrictions that would prevent the Church from using Mystic Dr as a means of primary access for the construction of the energy storage system. We do acknowledge that the easement requires the Church to restore the road to its previous condition, which we have no issue with.

Are there specific areas of this easement that residents of Mystic Point are concerned about? I've also copied our real estate attorney, Mike Swedick, and Father McSweeney of St Augustine's to this email in the event that you'd like to organize a phone call to discuss this in more detail.
