EFFECTIVE DATE: May 31, 2019

REGULATION OF: Gas powered leaf blowers

TIME PERIOD ALLOWABLE: October 1st – May 30th: *(PROHIBITED: May 31-September 30 of every year)*

EXCEPTIONS TO PROHIBITION:

- Excludes cemetery properties and on pavement/impervious surfaces when the gas-powered leaf blower is being operated at half-speed.
- During times of emergency caused by storm or other exigent circumstances, the Town Supervisor may declare a temporary moratorium on ban
- Temporary permits may be granted by the Building Inspector for a period not to exceed seven days

TIMES/DAYS ALLOWABLE: All leaf blowers can only be operated:

- 8:00am-5:30pm: Monday- Friday, except Federal Holidays
- 9:00am-6:00pm: Saturday
- 10:00am-5:00pm: Sunday & Federal Holidays

ADDITIONAL INFO: No leaf blower may be used unless it meets current EPA exhaust standards, is operated and maintained in accordance with manufacturer's specifications, and operates at a noise level of 65 dBA or less

REMINDER: Using leaf blowers to move leaves or yard debris into Town streets, public property, storm drains or other lots is always prohibited.
