I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on August 14, 2012 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Susanne Donnelly. Members of the Board present were: Councilmembers Northern Wilcher, Eric Blaha, Geoffrey Harter and Peter Tripodi IV. Also present were Town Attorney Wayne Spector, Budget Officer Madeline Zachacz and Town Clerk Mary Ann Roberts.

II. PRESENTATION- O'Connor Davies, LLP-Auditors Review 2011 Audit

Supervisor Donnelly announced that our auditors from O'Connor Davies, LLP will share with us their conclusions on the state of the Town of Ossining finances for the year ending 2011. Tom, can you do the introductions?

Mr. Domonic Consola provided a brief overview of the financial report covering three budgets including Town General, Town Outside and Highway. The revenues for the Town General were \$4,763,778 for the original budget with an actual of \$4,853,130 and expenses of the original budget were \$4,624,250 with an actual budget of \$4,552,579. The fund balance at the end of the year was \$1,261,801. The Town General is in good condition.

The Town Outside Budget total assets for 2011 were \$2,374,777 with total liabilities of \$1,276,212 with a fund balance of \$1,098,565. The Town Outside is also in great shape. The Highway Budget has total assets of \$789,663 with \$226,024 in total liabilities and a fund balance of \$563,639. This budget is also in excellent condition.

Councilman Tripodi questioned whether the liabilities and assets could be separated from the Town Outside and the Town General. Mr. Consola stated that they were and suggested that he go to page 52 for unassigned fund balance.

Comptroller Thomas Warren stated that the Financial Highlights on Page 4 of the Management Letter were written by the Town and reviewed by the auditors. The Town Justice Court Audit still has to be accepted by the Town Board.

Councilman Tripodi questioned whether the \$27,000 was a change in employees. Supervisor Donnelly stated that immediate action was taken and gave kudos to Tom Warren and Dale Ferreira.

AWARDS PRESENTATION

We also have with us tonight a group of Village of Ossining employees who we believe deserve to be recognized for their exceptional team work during an emergency at the Ossining Community Pool on July 25th. While in the job

description of Life Guard you are expected to perform your duties, but rarely does one expect to be called upon to actually save a life. At times we must all stop to thank these unsung heroes that watch over our children, family members and friends and many times our neighbors, some of which some are senior citizens.

This group of dedicated employees know the regulars at the Pool, and immediately noticed when this swimmer appeared to be in distress. Thanks to their quick reaction and their fantastic training, they were able to continue CPR until OVAC arrived. Phelps Hospital also mentioned how impressed they continue to be with the staff of the Ossining Pool, especially after this incident.

Superintendent of Parks & Recreation Henry Atterbury was introduced as the names of the individuals being honored were read and they are:

Mr. Atterbury stated that this is the third time in two years that an individual has been saved from drowning in the pool. It was a very emotional time for all and they deserve a round of applause.

Councilman Wilcher stated that pay has nothing to do with saving lives. You are there to help those in distress.

G. Fulfillment of Agreement- Sale of Crawbuckie Properties to Village of Ossining

Councilmember Wilcher moved and it was seconded by Councilmember Tripodi that the following be approved:

Whereas, the Town of Ossining passed the following resolution in May of 1982 which, in pertinent part stated;

“Since the Town of Ossining has foreclosed on properties which also lie within the Village of Ossining, and; Since some of these properties (identified by Serial Numbers : 10, 12, 15,17 & 21) are valuable to the Village of Ossining for municipal uses and; since it is within the legal prerogative of the Town of Ossining to make mutually advantageous agreements with another municipality with regard to such properties; Now therefore be it resolved: That the above mentioned properties be sold directly to the Village of Ossining at the offering prices here listed:

For a total sum of \$425, with the conditions that at the earliest opportunity, they be designated for public use and exempt from all but special use taxes, and that the Village of Ossining waive any claim to any share of the proceeds of sale. Payment shall be in full at the date of closing , and any 1982 taxes for the balance of the taxing periods shall also be due and payable at said closing excepting 1982/1983 school taxes which shall become due on September 1, 1982.”

And,

Whereas, the actions ordered in the aforementioned resolution were never completed; now therefore be it

Resolved that the Town Supervisor of the Town of Ossining is hereby authorized to execute the deeds and other required transfer documents to effectuate the conveyance of the aforementioned properties to the Village of Ossining at a total price of \$425, in accordance with the prior Resolution of the Town Board and subject to any conditions of the transfer of the properties as set forth in the 1982 resolution.

H. Approval of Bid- Installation of New Water Mains

Councilmember Harter moved and it was seconded by Councilmember Wilcher that the following be approved:

Whereas, the Town of Ossining has opened Capital Project #2011-2175 entitled “Cedar Lane & Stormytown Road Water Mains”; and

Whereas, the Town of Ossining publically advertised and received bids for this project, entitled “Installation of New Water Mains”, according to specifications written by consulting engineers, Charles A. Manganaro;

Now therefore be it resolved that the Town Board of the Town of Ossining hereby awards the contract on this project to the lowest responsible bidder in the amount of \$279,937 to WJL Equities Corporation of 274 White Plains Road, Suite No. 7 in Eastchester, New York, at the recommendation of the consulting Engineer and review of the Town Attorney.

Whereas, the owners of the following properties have requested a refund and credit of real property taxes due to a clerical error; and

Whereas, the said applications for corrected tax roll have been reviewed by the Assessor and Westchester County Tax Commission, and it is their recommendation

that the applications be approved and implemented as described below; now therefore be it

Ordered and resolved that the following corrections be made and implemented on the Assessment Roll, and other appropriate records by the Assessor and Receiver of Taxes and any other appropriate officials of the Town of Ossining:

2012 Town General Tax: \$121.23

2012 Ossining Ambulance District: \$35.60

Total Refund: \$156.83

And be it further ordered and resolved that the refunds be approved and paid to the property owners who have already paid; and

Be it further ordered and resolved that to the extent that any or all of the foregoing corrections have already been made on the tax records of the Town of Ossining, the said entries and corrections, to the extent they are consistent with this resolution, are ratified and approved.
