The Regular Meeting of the Town Board of the Town of Ossining was held on April 9, 2013 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Susanne Donnelly. Members of the Board present were: Councilmembers Northern Wilcher, Eric Blaha, Peter Tripodi and Geoffrey Harter. Also present were Town Attorney Wayne Spector, Budget Officer Madeline Zachacz and Town Clerk Mary Ann Roberts.

#### I. Procurement Policy- Adjustment

Whereas, the Town Board of the Town of Ossining has agreed to aggressively pursue competitive bids on public works contracts; and

Whereas, New York State has recently raised the threshold for competitive bidding from \$20,000 to \$35,000;

Now, therefore be it Resolved that the Town of Ossining hereby adjusts its own Procurement Policy to reflect a similar change, raising the threshold for requiring competitive bidding to \$30,000 from the previous limit of \$20,000, effective immediately, and this change will be effectuated in all specified sections of the Town Procurement Policy.
