I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on February 13, 2018 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Elizabeth R. Feldman, Northern Wilcher Jr. and Jackie G. Shaw. Councilmember Karen D'Attore was absent. Also present were Town Counsel Christie Tomm Addona, and Budget Officer Madeline Zachacz. Town Clerk Mary Ann Roberts was absent.

II. PUBLIC HEARINGS IN THE MATTER OF

• Local Law No. 2 of 2018 Extension of Cold War Veterans Exemption

At 7:30 P.M., the Public Hearing was opened.

Supervisor Levenberg explained that this would extend the property tax exemption currently offered to veterans of the Cold War. Our Town Assessor explained that without passing local legislation this exemption would sunset and those veterans would no longer be eligible for this specific exemption.

At 7:35 P.M., Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the Public Hearing be closed.

• 2018 Cabaret License Renewal for Westchester Ballroom (adjourned until February 27th, 2018)

At 7:35 P.M., the Public Hearing was opened.

Suzie works tirelessly to make sure every detail is perfect, every vendor has a good spot, and every visitor has a great time, and more importantly, learns something, and we are sure that we could never do it without her. Several of us are planning to celebrate this well-deserved honor at the event in April, and I am very much looking forward to watching Suzie receive the 2018 Going Green Volunteer Spirit Award.

Finally, we saw a report today that names Ossining one of the 100 Safest communities of 25K+ residents in the country! NeighborhoodScout, a web based platform, shouted

us out as #29, just below our friends in Harrison at #20. The CEO of NeighborhoodScout speculates that distance to well-paying jobs in urban areas, coupled with a good school system and a high quality of life leads to reduced violent, and property, crime, and we are so very proud of Ossining for getting this great attention at a national level. Special thanks to OPD Chief Kevin Sylvester and his officers for the work they do daily to keep us very safe, but also thanks to all of you—a lot of what makes Ossining so safe is that we are great neighbors who look after one another, and so, this win belongs to all of us. Congratulations.

Councilmember Feldman announced that we are waiting for the snow and ice to melt before placing the rocks in the community. We are currently looking for a larger venue to paint our rocks.

IV.LIAISON REPORTS

V.DEPARTMENTAL REPORTS

Tax Receiver Holly Perlowitz provided the Board with her quarterly report:

- 2018 Town Tax Prepayments The Town issued a warrant and we were therefore authorized to collect Town Taxes. The County did not issue a warrant and therefore, we were unable (by law) to collect County taxes.
 - \circ Taxpayers who called and inquired or read e-mail blast paid the correct amount which was the 2017 TOWN (only) taxes.
 - Many Taxpayers sent in the TOTAL amount of their Town/County bill from 2017. Therefore, we had to refund the county portion. These refunds are in process and should go out by the end of the week, with a letter explaining why the refund was necessary.
 - o In summary we collected 2018 Town taxes of \$788,984.83 from 404 taxpayers, refunded \$155,650.83 to 49 taxpayers so the net collections were \$633,334.
 - Taxpayers were wonderfully patient and cooperative and Community businesses donated coffee and donuts and we got through it together – all realizing that this all happened so fast and that we had to work together! It takes "A Town"!!!!
- 2nd Half of School Collections went smoothly
 - We stayed open until 7 two nights experimenting with what works best for our taxpayers. We are speaking to taxpayers that come in and asking them what would help them to be able to pay their taxes with ease – an informal sort of survey.
 - More taxpayers seem to be paying online assume that number will only increase as more taxpayers become comfortable with the use of technology to pay their bills.
- Review Tax Collections and Uncollected Balance handout as of 1/31/2018. Additionally, through February 13th collected another \$663,431 and the new uncollected balance is \$2,588,658 including the liens of \$415,802.74.
- Town/County Bills are next targeting to get them out by the end of March
