I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on February 26, 2018 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Karen M. D'Attore, Elizabeth R. Feldman, Northern Wilcher Jr. and Jackie G. Shaw. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Madeline Zachacz and Deputy Town Clerk Ann Marie Rocco.

II. PUBLIC HEARINGS IN THE MATTER OF Visitors shall be accorded one (1) four (4) minute opportunity to speak on each public hearing.

Supervisor Levenberg stated that we are beginning tonight with three public hearings all surrounding a similar issue. Local Laws #2-4 ask the public to consider putting three individual referenda on the June 2019 ballot in the Town of Ossining to convert the elected offices of Town Highway Superintendent, Town Clerk, and Receiver of Taxes to appointed positions. We received a grant from the Department of State's Municipal Restructuring Fund to learn about the Ossining community's appetite for finding efficiencies through departmental consolidation, a grant that was originally submitted with the Village of Ossining. What we agreed would be a viable place to start is to learn how Ossining residents would feel about two "proposals," one to convert the position of Elected Town Highway Superintendent to an appointed position, and the other to convert the Clerk and Receiver positions to appointed ones and potentially into one combined title and shared office. Based on the pending retirements of two of the three elected officials who currently hold these seats, we saw this time as an opportunity to reflect on our delivery of services and how, if at all, we could improve them. We embarked on an information campaign with our consultant, who distilled the ideas into a website for the public to view and take a survey on their impressions of the scenarios we provided. Every Town parcel was mailed a postcard directing them to the site and asking them to participate in the survey. We received 177 responses, many of which were supportive of the concepts in theory and asking us to expound on them. We also held two "community conversations" at the Ossining Public Library to hear our residents' thoughts and answer questions. Assuming there is any appetite from the community to bring these referenda to a vote, the next step was to craft 3 local laws and open the public hearings to continue getting feedback, which brings us to tonight. We are going to open all three together because we want the record for each to reflect the collective conversations around the topic. As with all public hearings, these local laws are still an open issue—we will continue to take public input for the next several weeks and no decisions have been made. There are, of course, pros and cons to both sides of the issue, and we are here to listen.  Local Law #3 of 2019 – Abolishing the office of Elective Town Receiver of Taxes and creating the office of Appointive Town Receiver of Taxes subject to a mandatory referendum

At 7:54 pm, Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the Public Hearing be adjourned until March 12, 2019.

At 7:31 pm, Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the Public Hearing be opened.

 Local Law #4 of 2019 – Abolishing the office of Elective Town Clerk and creating the office of Appointive Town Clerk subject to a mandatory referendum

Andre Lamar Ossining resident had the following questions:

- Since this is going to be a new system what are the qualifications of individual board members to be questioning who is going to be the best fit for these positions?
- What happens to the records that you are going to keep on the individuals that are going to be selected?
- Would the person who is going to be selected for any one of the three positions going to be a resident of our community such as the Village/Town of Ossining.

Town Counsel Christie Tomm-Addona explained that there are record keeping rules that are in place and need to be followed and we can make regulations available on the Town website. The Town Board can also consider residency if and who they want to appoint to these positions when it comes to that time.

Budget Officer Madeline Zachacz spoke about Civil Service. Once the Highway Superintendent position is no longer elected it becomes the same name but just an appointed position and now there are qualifications and a civil service list. The Town does have the choice to take from the Westchester County list or local list if one exists.

Mindy Lamar Ossining resident questioned:

- Why these three positions? Why not appoint school board positions? If we look at the people that are in these positions now, they are elected and tenured employees.
- o What happens down the road with future administration?
- Why not let the residents decide? Why take the voting away from us?

Budget Officer Madeline Zachacz explained that competitive titles do not apply to the Tax Receiver or the Town Clerk position. Since they are not competitive positions, they would be appointed by the Town Board.

Art Sullivan Ossining resident questioned the following:

- o If this is a cost savings matter, why are we holding a referendum in June?
- The Town and Village were talking about merging the Highway Departments. Is this first move of that?

Town Counsel Christie Tomm-Addona explained that the Town Board would have to pass a local law abolishing these elected positons and creating the appointed positions and then sent to a mandatory referendum.

Supervisor Dana Levenberg stated that since there is a primary in June, we will not incur the cost of the election.

Kim Jeffery Ossining resident explained that she is concerned about abolishing these positions and not having them elected and she does not feel that this will not end up being a cost savings for the Town.

John Van Steen Ossining resident questioned the salaries that we have been paying these elected officials substantially less than what other communities pay for their civil service personnel. Mr. Van Steen stated that we have elected quality people in the past and feels that this will continue.

All members of the Board are in agreement with adjourning these public hearings until March 12, 2019.

At 7:54 pm, Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the Public Hearing be adjourned until March 12, 2019.

II. ANNOUNCEMENTS

Supervisor Levenberg announced the following:

We are working our way into tax exemption season, and you may have heard some news about changes to some tax exemptions. Our Assessor's Office is always happy to help, and asked that I share the following message. As always, they can be reached at (914) 762-8274 if you have any questions.

"The New York State Department of Taxation and Finance reminded property owners age 65 and over who are applying or reapplying to receive the Enhanced STAR exemption in 2019 that they must now enroll in the Income Verification Program (IVP). Those already enrolled in the IVP don't need to take any action to continue receiving their Enhanced STAR exemption. New IVP enrollees will likewise automatically receive the exemption each year they're eligible.

In the first year of enrollment, the assessor will verify eligibility based on the income information provided by the homeowner. In subsequent years, the New York State Tax Department will automatically verify eligibility. As a result, homeowners will no longer need to renew the exemption or share income tax returns with their local assessor's office.

This change applies only to seniors 65 or older applying for the Enhanced STAR exemption or those who have the exemption included in their property tax bills. This doesn't affect those who receive a check for this exemption because New York State Tax Department already verifies income eligibility. If you already receive the Enhanced STAR exemption but aren't yet enrolled in the IVP, you must renew your application for the Enhanced STAR exemption and enroll in the IVP. The forms

were already mailed to you, please submit as soon as possible but prior to May 1, 2019.

If you're also receiving the senior citizens exemption, you'll still need to annually renew that benefit with your assessor. The renewal application will be mailed to you the first week of February.

In the past, seniors who qualified for the senior citizens exemption were automatically granted the Enhanced STAR exemption. Beginning in 2019, you must apply separately for both exemptions.

The deadline for all exemption (Veterans, senior, disability, county firefighter, clergy, non-profit organizations, etc..) applications and renewals is May 1st 2019. Please call the Assessor's office if you have any questions at 914-762-8274."


Mr. Fraioli explained the main scope of this project and the road is in need of major restoration.

Superintendent Andrew Tiess spoke about the water main replacement on McCarthy Drive.


McCarthy Drive Roadway Rehabilitation


Roadway Layout Plan











Grading and Drainage Plan






Utility Plan







Councilmember Feldman questioned what happened to Con Ed gas?

Town Supervisor Dana Levenberg explained that Con Ed now has a moratorium in place starting March 15, 2019.

Village Engineer explained that if the moratorium gets lifted, the intent right now is to have these designs get to construction document phase in the next few months and have construction commence this Summer.

Councilmember Wilcher question if the road would have to be lowered to accommodate a curb?

Engineer Paul Fraioli explained yes, this better storm water practices.

Bob Hooley McCarthy Drive resident questioned what is the width of the proposed roadway between the curbs?

Village Engineer Paul Fraioli explained it will be 21 to 24 feet.

Mitchell Yonkler McCarthy Drive is concerned about the end of the road because there is no way to turn around. Feels that this a dangerous situation.

Village Engineer Paul Fraioli explained that we are aware of the dangers and we are proposing a hammer head.

Bob Katz Incognito Drive:

• Have you decided the positions of the catch basins where the dirt road begins?

Village Engineer Paul Fraioli yes, drainage positions are in the plans.

• What about the underground water way? What are the plans? What is the flow rate?

Village Engineer Paul Fraioli explained that we know that there is a lot of water on the hill and will elevate with sub base and the water will make it out to the ground. The road will be impervious and it will enhance the water way.

• Is the present plan not to take the easement into Incognito?

Village Engineer Paul Fraioli no, we do not plan on connecting Incognito to McCarthy Drive.

Terrance Lennon White Birch Drive would like to request a hard copies of all the drawings.

Village Engineer Paul Fraioli explained that these drawings are not final.

Supervisor Dana Levenberg stated that our camera has zoomed in on these maps and you will able to view them on our Youtube presentation.

Ossining resident questioned:

• Have you seen how many people have installed French drains due to the creek behind White Birch? This resident is concerned about getting water in her yard. She has spent \$20,000 in drain work.

Ossining resident explained that her backyard is a lake. The water flows there from McCarthy Drive. Why are you stopping at McCarthy? There are other drainage issues.

Village Engineer Paul Fraioli explained that it would be premature to design any improvements. The Highway Superintendent will keep an eye on this system.

McCarthy Drive resident questioned:

- Is it your intention to sit down with each property owner to go through their lot and discuss how things are going to work out?
- How will we be compensated for the work that needs to get done?
- Who pays for the 2 million dollars? Is this in the budget?

Village Engineer Paul Fraioli explained that this part of a bond with the Town. There will be no residential cost to this project. Yes, we will have individual home owner meetings.

Dan Fortini Incognito questioned what are the plans for the tank? What is the schedule and how will it impact Incognito?

Village Engineer Paul Fraioli explained you might have intermittent access and you will be able to park near your residence. If you live on Incognito you will have access to your parcel at all time.

Marco Goncalves McCarthy Drive resident stated that Village Engineer Paul Fraioli saw no need for curbs or widening the road.

Village Engineer Paul Fraioli explained that curbs provide better storm water management and we are lower the road.

Catherine Manarino McCarthy Drive resident questioned what will this do to property taxes on McCarthy Drive?

Village Engineer Paul Fraioli feels that he doesn't believe that the Assessor cannot increase your taxes on a public improvement in the right of way. Our Town Supervisor will confirm this.

McCarthy Drive resident how wide will the road be during the construction?

Village Engineer Paul Fraioli explained the estimate will be based on the excavation.

McCarthy Drive resident questioned

- Are they proposing street lights?
- How many people to do you need to install gas?

Village Engineer Paul Fraioli stated that they are not proposing lights on this streets.

Supervisor Levenberg stated that we will look at the interest in the gas line.

Whereas, in 2018 the Applicant requested extended hours during which it could play amplified music from 12:00 midnight to 1:00 a.m. on Fridays and Saturdays, which request the Town Board granted on a three-month provisional basis and then for the remainder of the 2018 calendar year; and

Whereas, the Town Board is authorized under Chapter 68 of the Town Code (Section 68-20(B)) to extend hours a cabaret may play music beyond what is permitted in the Code where it deems it appropriate and consistent with the public safety and welfare; and

Whereas, the Town Board has reviewed the 2019 application and attachments thereto, and has solicited input from involved departments, including the Police Department and Building Department; and

Whereas, on February 19, 2019, the Town Board opened a duly-noticed Public Hearing on the subject cabaret application, at which time no members of the public appeared to speak on the application, and the public hearing was closed on February 19, 2019; and

Now therefore,

Be it Resolved, that the Town Board of the Town of Ossining hereby approves the application of the Maya Riviera Bar and Restaurant, 518 North State Road Briarcliff Manor, in the Unincorporated Area of the Town of Ossining, for a Cabaret License for the 2019 calendar year, subject to the following limitations and conditions:

- 1. The music played on site will consist only of (a) a Mariachi Band consisting of 3-5 members using guitars and trumpets or (b) a DJ using a Karaoke Machine
- 2. Amplified music shall be allowed on Sunday through Thursday from 11:00 a.m. 11:00 p.m. and Friday and Saturday from 11:00 a.m. 1:00 a.m.

Be it further Resolved, that the Town Board finds that based upon the lack of complaints from the public or the Town's departments and the positive role the Applicant's establishment plays in the community that it is appropriate and consistent with the public safety and welfare to allow the Applicant to play amplified until 1:00 a.m. on Friday and Saturday nights, but reserves the right to revisit this determination in subsequent years and make any modifications to the

hours during which amplified music is permitted that the Town Board deems necessary based upon the circumstances presented at that time, and

Be it further Resolved, the conditions on this cabaret license are only for the 2019 calendar year and the Town Board reserves the right to modify, add to and/or eliminate any and all conditions when considering the Applicant's application for a cabaret license renewal for the 2020 calendar year in accordance with Chapter 68 of the Town Code.

I. Authorizing Levy of Unpaid Water Charges on Town Tax Roll

Councilmember D'Attore moved and it was seconded by Councilmember Feldman that the following resolution be approved.

WHEREAS, pursuant to an Inter-Municipal Agreement ("Water IMA") dated January 1, 2002, the Village of Ossining supplies water to the Unincorporated area of the Town of Ossining ("Town Outside") and directly bills consumers in the Town Outside for water supplied pursuant to the Water IMA, and

WHEREAS, pursuant to the Water IMA, any water charge that is delinquent for three or more months shall be levied against the delinquent property by the Town and shall be subject to penalty in the manner provided by law, in which event, upon collection by the Town, the Town shall remit the amount collected to the Village of Ossining; and

WHEREAS, pursuant to Section 198 of the Town Law, the Town of Ossining is authorized to levy unpaid water charges against delinquent properties;

NOW, THEREFORE, BE IT RESOLVED, that any water charges to a customer outside of the Village of Ossining corporate limits and in the Town of Ossining that is delinquent for three or more months shall be levied against the delinquent property and shall be subject to penalty in the manner provided by law.

AND BE IT FURTHER RESOLVED, that the Village Treasurer, on behalf of the Village Clerk of the Village of Ossining, shall file with the Supervisor of the Town of Ossining, as required by law, statements showing unpaid water charges to customers outside of the Village of Ossining corporate limits, but within the Town of Ossining, which are delinquent for three or more months and that such statements shall contain a brief description of the property upon which the water was used, the names of the persons or corporations liable to pay for the same and the amounts chargeable to each for the purposes of levy and enforcement under "Water Rents" and upon receipt of such statement, the Supervisor will transmit said statement of delinquent water charges to the Receiver of Taxes for levy against those delinquent properties.

Supervisor Levenberg stated that Last week, the Board received a memo from our Town Comptroller Tom Warren detailing this annual process, as well as giving us a list of delinquent parcels and balances due. These will be added to the aforementioned Town/County bill for those customers in the Unincorporated Town who have not paid their Village water bills timely. Tom was willing to join us tonight to answer any questions from the Board, but seeing as today is his birthday, we decided to let him play hooky tonight.

Supervisor Levenberg stated that you may remember that last year we began the process of inventorying the street trees in the Town of Ossining, beginning with some of our main thoroughfares and commercial areas, namely North State Road, NYS Route 133, and NYS Route 134 and Louis Engel Park, funded by a grant from the New York State DEC Urban and Community Forestry Program. We recently received a second grant from the same program in the amount of \$50,000 to complete phase two of this inventory to include the remaining roadways in the unincorporated area and all town parks. The next step will be to issue a request for proposals to obtain quotes from vendors to complete the inventory with the grant funds we have received. This project will provide us with some more information about the benefits our street trees provide to the environment and will help inform future strategies to maintain a healthy community forest here in Ossining.
