Dear Mr. Carrera:

I am not normally in the habit of expressing a *mea culpa* but I am doing so now in regards to my previous written comments regarding the application of the Bethany Arts Community (BAC) for approval of numerous variances for their property at 40 Somerstown Road. Their request was submitted to the Town of Ossining Zoning Board of Appeals (ZBA) and was the subject of an online public hearing held on June 29, 2020.

Dozens of neighbors and other Ossining residents submitted their comments on the application and many of them addressed them publicly during the meeting. Representatives of the BAC explained the programs that they wanted to implement, and members of the public questioned them and expressed their feelings regarding the request. BAC explained that the variances were necessary to the implementation of their mission because their property is currently zoned for residential use only (R-40) and the town code did not permit these uses in that zone.

All of the property owners that abut the BAC property on Cooper Drive, Stonegate Road, Tavano Road and Somerstown Road (Route 133) received a notice of the meeting and which included a list of numerous activities proposed by BAC. I, amongst many others, objected to their proposal and stated so in my written comments to the ZBA on prior to the meeting. Conversely, there were a similar number of residents who supported the proposal of the BCA.

My objection to the proposal was based upon my belief that these proposed uses were, besides being illegal, (1) out of character to the neighborhood, (2) potentially a huge nuisance to the abutting homeowners and (3) a traffic issue to everyone else. I actually described their proposal as being tantamount to an "Amusement Park" and emphasized and questioned the concept of installing Beehives.

As I listened to the various speakers during the meeting I came to the conclusion that I had over-reacted to the BAC's proposal and simply opposed it based upon its unique uses in a zone that was for a completely different use. Perhaps it was my professional

real estate knowledge and background that told me that "Amusement Parks" are not permitted in residential zones.

Numerous speakers at the meeting spoke in favor of BAC's proposal as positive to the community and important for Ossining's economic development. Most of those who spoke against BAC were abutting owners who related stories about incidents of slight noise during a children's activity taking place on the BAC property and many of them stated that this was not a serious problem at all. As these stories were told, my negative opinion of the BAC proposal was withering away.

I have been on the BAC property a few times over the past years to attend certain events but never paid attention to which homes actually abutted the property. After the June 29<sup>th</sup> meeting, I drove onto the property to see for myself how many homeowners were possibly negatively affected by the variance proposal. My total count is approximately as follows:

Street	# of Homes
Cooper Drive	9
Tavano Road	10
Somerstown Road (Route 133)	10

For visualization purposes, at the end of Cooper Drive there is a huge white water tower which is the approximate boundary where the BAC level land becomes heavily wooded and drops off into an unusable state at this time. About 13 houses on Stonegate Road actually abut the BAC property but they are located in the heavily wooded lower rear part of the property. On Tavano Road perhaps a half dozen homes abut the cleared level land of BAC. The homes on Somerstown Road are actually across the street from the BAC entrance and do not abut it.

So, what is the potential negative impact of granting to BAC the requested variances in order that they can offer and conduct a great many programs to the community and implement the reasons why BAC was established? In my refreshed opinion the answer is not much. However, in my professional real estate opinion I believe that there is a significant potential that could have a much more serious negative effect on the entire neighborhood. Please allow me to explain.

We know that this property contains just under 25 acres of land and is zoned for single-family homes, each on a 1-acre parcel. I am not an engineer but assuming that all of the land is usable and allowing some acreage for streets, etc. perhaps 20 buildable parcels can be created. With each home on a 1-acre parcel of land these could be sizeable and expensive homes. Alternatively, they might be less expensive, but socially desirable, residences under a variety of federal and state programs. I would not want to live on an abutting parcel during the during the development and construction years. While I am not appraising or valuing the entire BAC property, just looking at it for its development

potential I believe that it is worth well into 7 figures today and it would undoubtedly draw the interest of numerous developers. I am also not encouraging that this be done.

My point in my "real estate" or "development" analysis is that it seems to me that the current use, including the slightly more expanded use of the property, that is suggested by the current application, is far more benign and far better aligned with the neighborhood and its residents' expressed aspirations than any probable "as of right" use to which the property could be put by a potential developer. We have a good neighbor, with an idealistic and largely non-intrusive vision for the property. It seems to me that we are far better off coming to some reasonable compromises with the BAC, which would support and enable the uses for which the property is currently intended, than to alienate them and introduce the possibility of a massive development that is within the R-40 constraints and which would likely be far more intrusive and unresponsive to the expressed desires of our neighbors.

Post-public hearing, it appears to me that the Town of Ossining is presented with a zoning issue that has two potential answers: 1) grant the variances in whole or in part, or 2) anticipate that one day in the not too distant future the development of this property may very well be the subject of a Planning Board meeting.

I would be pleased to discuss my current thoughts on the BAC variance issue at your convenience.

As a resident of Stonegate Road, the proposal of a public trailway going through the back yards of many of the people who live here is a little disturbing. There is already a road that provides connectivity to Ryder Park. Anyone can walk down the road or ride a bike to Ryder Park from the street. Why would anyone want an additional public trail in the back yards of 20 to 30 residents that live in a single-family neighborhood. What will happen to their privacy? When you have a back yard, in most cases you are connected to another property by back yard or side yard. The general public, or bike riding, wouldn't be permitted in between those property lines. Stonegate Road has a cul-de-sac at the end and that little bit of privacy is why most people like living there. Let us first say that we find the overall vision and goals of the Bethany Arts Center petitioning this board to be laudable, in common with the churches and schools that share special use designation within the subject R40 zoning. Regardless of the laudable goals of all these organizations, the Town of Ossining Zoning Code and the language related to the town's planning and zoning boards' responsibilities regarding special uses recognize that these special uses require constraints to limit their impact on the neighborhoods within which they are embedded. In accordance with this established mission and the guidance of the Town Zoning Code, these town agencies approved petitioner's prior special use permit application only after substantive changes were made to petitioner's original proposals. Petitioner's current proposal substantially increases petitioner's overall footprint in a number of ways relative to the previously approved special use permit. These increases make this application closer to a new application than a renewal application.

The special use restrictions incorporated in both the R40 zoning regulations and the required agency review of any special use permit recognize that facilities likely subject to regular and/or public use by the typically non-resident users of the subject special use property are fundamentally different in their need for regulation than property uses by residential homeowners and their guests. This is perhaps due at least in part to the fact that, in general, special use facilities are less able to exert control over the behavior of the users of the facilities than are resident homeowners. Special use facilities may also include substantially higher user numbers at higher frequency and abut residential properties with an inherent expectation of privacy. As a result of these and perhaps other reasons, setbacks of 100 feet from any lot line are required for most special use facilities located within the property of any special use applicant. This setback is specifically called out for at least buildings and parking lots, but the intent to separate facilities for the public/non-resident activity inherent in these community benefit special uses by at least this distance permeates the code. Petitioner's previously approved special use permit was based on a plan that called for new envisioned public/non-resident activity facilities (in this case walking trails) to be located a revised at least 100 feet from the lot line. This is the distance established as appropriate by both the preponderance of the Town Code and the prior operation of the town's regulatory agencies.

Despite this fairly clear intent of the code and the overall mandates of the regulating bodies, petitioner is now proposing facilities that extend to the perimeter of petitioner's property. In particular these facilities include at least "Community Gardens." Petitioner's property is quite large, with substantial areas located further than 100 feet from the lot lines. Despite the availability of such areas for the proposed uses, petitioner specifically rebuffed direct suggestions to change the plans so that such areas would be used instead of areas located immediately adjacent to neighboring residential lots. Constraining the proposed facilities to the areas located at least 100 feet from the lot lines would not materially impact petitioner's ability to provide the intended community benefits. Failure to do so would establish an unfortunate precedent for potential future petitioner requests or actions to locate additional facilities abutting neighboring properties.

As a result we believe that consistent application of the letter and intent of the governing code would require that in any special use permit provided to petitioner, this board would in such permit constrain all of petitioner's proposed or future facilities to areas located at least 100 feet from any neighboring lot line. Any and all alterations to promote use of petitioners property should likewise be constrained to areas located at least 100 feet from any neighboring lot line.

We are writing with a number of concerns and questions regarding the Bethany Arts Community 2020 Amendment. We urge the Zoning Board of Appeals to address these issues and consider not approving the permit. We live at 29 Stonegate Road in the Town of Ossining and have resided in our house for 26 years. We are actively involved in the Ossining community, volunteering in many capacities over the years that we have lived in Ossining, and working as a science teacher at Ossining High School for 25 years.

Our house is adjacent to the Bethany Arts Community property. With the use of the wooded area as part of camps, there has been an increase in the noise level behind our house. We are concerned for a further increase in the noise level behind our house with the proposed amendment. In addition, we are apprehensive about the ecological impact of increased human activity in the wooded area.

Please address the following questions/concerns:

- 1. What will the size of each program be and will there be a maximum number of participates in each program? What will be the maximum number of students in the after school programs, summer camps, and theater camp? How frequent are the programs? Do they occur every day? What hours do they occur?
- 2. On the attached paperwork, it states that "all and any of events that would occur outside will happen only during daylight hours in keeping the immediate neighbors in mind." However, on the attached site plan, it states that proposed seasonal events would occur between 8:00 am to 9:00 pm. This extends beyond daylight hours. What hours will the outside activities occur?
- 3. How is the community garden going to directly involve the neighbors?
- 4. Will the walking trails be open to the public with the potential for an increased amount of people being on the extended trail behind our house?
- 5. How can the BAC become part of the trail system leading from Ryder Park through Bethany to connect to the Briarcliff Peekskill Trail and Teatown Reservation? There is no indication on the site plan how this would be done.
  - a. Where is the access point to Ryder Park?
  - b. Would the trail be extended to pass through private property?
  - c. How is this trail going to be maintained?
  - d. The site plan does not show how far the area and trail would be extended into adjacent properties. Can this be shown in a diagram?
- 6. How will the property be maintained to prevent litter and prevent individuals from leaving the trail and entering private property?
- 7. How will the increase in traffic to and from BAC be addressed?
- 8. Is there going to be busing of children from NYC?
- 9. Are any of these programs being subsidized by local government?

10. Is BAC planning on serving alcohol at Artoberfest? How many participates are expected? Will the walking trail be used and how will this be monitored to ensure the safety of the neighbors?

Thank you for taking the time to address these questions and concerns.



I hope you are doing well.


I will not be able to attend the planning board meeting this Monday regarding Bethany Arts Center so I am writing a letter to share my thoughts and feelings.

Dear Mr. Carrera and members of the Board,

By way of introduction, I own one of the properties (19 Stonegate Road) that is adjacent to the BAC. I am very concerned of the BAC's proposal that is currently under consideration by the Board. My Mother, who currently lives at the property, is 92 years old. I grew up at 19 Stonegate Road and my family has owned the home for more than 45 years. My family and I currently live at 23 Apple Lane, Briarcliff Manor and as a result of our lifelong commitment to Briarcliff and Ossining, my family and I are invested in this decision.

In my opinion, the special permit BAC is requesting would not only put my Mother's safety at risk, but also cause undo harm to the local residential community. Although the proposal sounds admirable at first glance, there are several considerations the Board should consider prior to deciding on the special application put forth by the BAC.

- Increase of trespassing, intentional or not, to the local homeowners as a result of a new trail system proposal leading from Ryder Park through Bethany to connect to the Briarcliff Peekskill Trail and Teatown Reservation.
  - The safety of my Mother and others in the residential area should be considered as there is an increase of individuals walking through the neighborhood and backyards.
     The new trail will not only attract BAC members and participants of the programs, but others that will utilize the trail outside of BAC's control.
  - b. I would respectfully request BAC to propose how they will guarantee the safety of the residents, prior to the Boards decision.

# 2. Increase in noise level due to on-going camps.

- a. Although hearing children's laughter, banter and screaming is a wonderful sound, hearing it all day long could get to anyone after a period, even parents. The community of Stonegate, Cooper and the surrounding neighborhood has always been a quiet and peaceful community. This is one reason people choose to move there in the first place. Adding summer camps, basically in our backyard, changes joyful, peaceful summer days / months to loud and noisy days / months due to day camps.
- b. I would respectfully request BAC to propose how they will decrease the noise level for the residents that border the BAC property, prior to the Boards decision.

## 3. Increase of traffic on 133 during peak pick-up and drop off times.

- a. The increase in traffic will cause residents to have difficulty turning left out of Cooper or any of the neighborhood roads along 133 and will also put additional stress on an already dangerous intersection(s) of 9A and 133, specifically near the Getty gas station.
- b. I would respectfully request that BAC conduct a traffic study to advise the Board of what the proposal will do to the local traffic, prior to the Board's decision.

# 4. Increase in cars and visitors will have an impact to the local environment.

a. With the increase in traffic, increase of visitors and the creation of new trails, I respectfully request the BAC to conduct an environmental impact study on the surrounding woods and flatlands in the area, prior to the Board's decision.

In summary, the decision by the Board to approve BAC's special permit should not be taken lightly and only after serious consideration of the impact to the local residential community. Thank you for your consideration on the above points and hope that there is a reasonable compromise that can be made for all parties involved.

I am writing to you to express my concern regarding the application of the Bethany Arts Community for many additional variances to the use of their property at 40 Somerstown Road.

I have lived on Stonegate Road for 40 years and for all of that time the Bethany property has always been a good neighbor. This property is zoned R-40 yet it is not used for single-family one-acre homes and never has been. Their uses, especially under the fairly new, non-religious, owner has never, to my knowledge, been disruptive to its surrounding residential neighbors. Based upon the requested use variances specified in the Bethany application, that is about to potentially and severely change. From a history of quiet uses, the new owners want to materially expand their existing programs to include, among many others, children's camps, outdoor theaters and **BEEHIVES?** Are they serious about that use?

With this very expanded list of uses that Bethany is requesting I believe that you need to consider how they are going to be monitored and enforced? With all due respect to the excellent work that John Hamilton does as our Building Inspector, is it feasible that he will have sufficient time in his part-time job to fulfill all of his other responsibilities while also monitoring these newly-allowable uses including **BEEHIVES?** Also, please bear in mind that the Bethany property is **tax-exempt** and has been from day one all those years ago. How much uncompensated municipal labor do we want to devote to this proposed use in the never-ending enforcement of the requested variances?

While I understand the need for a virtual public hearing at this time, hopefully the time will come shortly when you will be able to hold a public hearing on this matter before a live audience of abutting property owners so that you will be able to personally listen to and question your fellow citizens about their feelings on this matter. Please put yourselves in the place of a homeowner whose property abuts the Bethany Arts Community today and who is now facing the addition of an Amusement Park in their backyard.

As an alternative to this long list of requested variances perhaps the proper procedure might be for the applicant to request a complete rezoning of the entire property to a zone that is newly-created and which allows these specific uses. That would require an Environmental Impact Study along with a traffic study and which would address all of these issues on a professional basis. This variance application is, in essence, a rezoning request that must be addressed in a manner that is in the best interests of the Town of Ossining and its residents and should not just be simply approved via the one-page multi-variance request. A one-page request should not be answered in a one-page response after just one short hearing.

Think of yourselves as abutting owners and how you would want your appointed and elected representatives to fulfill their responsibilities.

Attention Board of Appeals,

I am writing with much concern over the proposed changes to the BAC Application coming before the Board on 6/29/2020. Below is a list of some of my concerns.

- 1. It appears by the map included in the BAC application they are proposing to vary from the 100' set back as agreed on the original application. This includes a "community garden", additional trails (including a proposal to join other park trails) and potentially beehives. I believe BAC has a lot of property and should find space within the original setbacks.
- Hours of operation proposed seems to be all over the place. Application says 8 am - 9 pm, application narrative says daylight hours and an email sent out to residents by David Lyons on 6/26/20 says beginning at dawn.
- 3. <u>Community Garden and Beehives</u> In reference to the community garden. Proposed letter says "directly involve our neighbors" and the email sent by Mr. Lyons says " no access by general public". This seems to contradict itself.
- 4. Noise Mr. Lyons email refers to "noise issues with several neighbors" in the summer, but falls to mention him allowing (with out Town Approval or a permit) a film crew all day and late into the evening on Oct. 9, 2019. Large lights brightly illuminating our neighborhood. With idling tractor trailers. Large lights and big tents. When approached on this subject, BAC chose to use the excuse that they weren't aware they needed Town permission. Remember that they also used our Town water tower as a billboard for BAC with some type of projection machine on Feb 23' 2019.
- 5. Participant limit BAC is requesting a considerable amount of new pedestrian as well as auto traffic with this proposal. Because of past experiences I think it's very important that the Board pin BAC down to exact limits on quantity of people coming through the property. Along with Hours, frequency of the events, participant limitation, date ranges, and how to control crowd overflow into the community (parking and foot traffic). How will they actually monitor and control all of this?

From a local residents observation, Mr. Lyons doesn't seem to take The Town Planning Board, The Town Building Dept. or his immediate Town neighbors into consideration. He has stated in the Proposed Use Letter that he takes a "when in doubt reach out mentality". He didn't ask about a film permit. He didn't ask for permission to light up a Town water tower promoting BAC and if there needs to be permission for Bee Hives he has already erected them and they are in use.

Please hold My Lyons to specific details of all of his proposed projects because I feel that he will do serious alterations without permission with the excuse he didn't know. Which would be detriment to our levely neighborhood we have worked so hard to maintain.

My wife and I - and our young son - reside at 25 Stonegate Road, Ossining, 10562. We have been living here since July 2010. Our home directly abuts the Bethany Arts Community (BAC) property.

While the BAC has generally been a good neighbor - and the goals of the organization are admirable - we have concerns over the new plans submitted and the BAC is requesting special permitting for. The plans appear to be a significant deviation from current use of the property (zoned as R40 residential). It's also not clear from the plans as to whether the new BAC requests will allow for spacing at least 100 feet from neighboring lot lines.

We looked at the additional information provided by BAC on the ZBA site dated 6/25. We appreciate the additional information, but much of it seems confusing or different from the original Amendment. For example, the original request indicates camps that may provide for children in New York City. The additional information notes these camps would be for Ossining's children. Which is it?

Walking trails, Gardens and Outdoor Exhibits: It's not clear where these would be built and take place.

At the minimum, it seems more concrete information may be needed to properly address these requests - or perhaps It may be more suitable for BAC to apply to have the property rezoned.

Thank you for the Building Department and Zoning committee for reviewing this request and soliciting public feedback.





Dear Ossining Zoning Board of Appeals:

I am writing in support of Bethany's application for a special permit for outdoor use. I am writing with several different hats on. I am the artistic director and owner of Theater O. We run the Harry Potter Camp and the Show Camp at Bethany. I am also a Board member of Bethany Arts Community. I am also a resident of the Town of Ossining, and a parent of two children in the school district, a rising third-grader and a rising 10th grader. My husband, Andrew, is a resident artist at Bethany and has a studio there where he makes puppets, writes plays and builds toy-theaters. I have several insights into this application and I would like to share them with you.

First, the camps: For two years Theater O has held the Camp of Witchcraft and Wizardry, a Harry Potter-themed arts-based educational camp at Bethany. About half the activities were indoors and half outdoors. To my knowledge, we (both Bethany and Theater O) never received a complaint in those two years from anyone, either in writing or verbally. No child was ever hurt beyond a scrape. The maximum number of children who attended the camp on any given week was 32. We had 4 counselors, one assistant counselor, and two lead teachers. The child-adult ratio was never higher than 8:1 and almost always closer to 5:1. After David Lyons' last ZBA appearance where we (both Bethany and Theater O) learned that outdoor camp was not approved, we made two plans. One: hold the camp indoors and outdoors again. We anticipated that David would go before the ZBA in early 2020 and that a special use permit would be granted and that we would be able to continue our activities as before. Two: hold the camp entirely indoors and fashion a quidditch pitch in the performance space, collect the natural materials we use in the forest and bring them inside and have our campers experience an Indoor Hogwarts like environment, complete with a magical projected changing ceiling and a "Room of Requirement", making magic that matches our campers' imaginations. Then came the pandemic, and now we are holding the camp virtually. The show camp, where campers put up a show in one week, soup to nuts, has always been held entirely indoors.

Theater O productions have all been held indoors.

I feel terrible that we (both Bethany and Theater O) unknowingly held a camp partially outdoors that we shouldn't have because the camp is universally loved by those who attend it. It is, by Westchester standards, inexpensive, and we offer scholarships. I know now that I personally should have done more research. I know as a Bethany Board member and as Theater O entering into a contract with Bethany, we (both Bethany and Theater O) should have asked more questions of Bethany's legal counsel at the time. But we didn't. And I am very sad and sorry about that. I am admittedly, very good at the art-making and cultivation of the imaginations of children and adults and building artistic communities. I am less versed at this end of things.

I would also like to address why I think Bethany should be allowed to hold outdoor programming. Bethany is only trying to enrich the experience of our community. The possibility of having an outdoor art walk, a place where people can experience beauty in solitude, or with a group is an exciting possibility for Ossining. The idea behind Artober fest is to have one day a year, in the middle of the Bethany residency, where local artists and our visiting resident artists can come together and make art, and experience beauty together. I have full confidence that David and the board and staff at Bethany only want to work with neighbors to find the sweet spot where things can happen.

As a theater director for all of my adult life, and now as a teacher, I spend much of my time with scripts and students, trying to understand a character's perspectives and motivations. I can see how from the perspective of some that it could look like Bethany and Theater O were flouting zoning laws, and operating under a "ask for forgiveness later" mentality. I want to assure you that this is not what occurred here. Ignorance, yes. We didn't do enough homework. We got some bad advice. We thought we were asking the right questions to the right people and we weren't. Please know, no one was purposefully ignoring zoning laws. The only thing that was consciously happening was we were trying to put beautiful, meaningful experiences into our community. I think in large part we have succeeded in doing that. I hope that a conversation can occur where all parties can be satisfied and that Bethany can offer unique outdoor artistic experiences that enrich all of our lives.

The intersection of art and community has always been an important part of the world to me, but it is also particularly important right now. In this moment where we need social distancing and outdoor space and beauty and joy, Bethany has all of this to offer.
