DJ using a Karaoke Machine shall be allowed on Sunday through Thursday from 11:00 a.m. – 11:00 p.m. and Friday- Saturday 11:00 a.m. -12:00 a.m.

Mr. Gershner stated that in an effort to make the taxation between condos and houses fairer, there are ways to lessen the immediate real estate tax increase to the condo owners. As we recently done for those homeowners who received a substantial real estate tax increase after the revaluation, perhaps instituting a phase in over a number of years, maybe 5 to 7, would aid in the adjustment to the higher taxes. However, during the phase in period any sale of a condo unit would result in its immediate full market value assessment.
