#### ZAPPICO CAR WASH, 558 North State Road, Site Plan Approval

The applicant requested the application and public hearing be put on hold in an email memo, dated October 7, 2010. In the memo, Mr. Zappi noted that he will explore the possibility of developing the site as residential. This was removed from the agenda.

## Review & Recommendations of the Town's Comprehensive Plan

Mr. Stolman submitted and reviewed with the Board, a revised draft of proposed local laws to implement recommendation of the Town's Comprehensive Plan. Six local laws were reviewed and discussed:

- 1. Amending the Zoning Law to remove the R35 and R15X One-Family Residence-Office Districts.
- 2. Amending the Zoning Law to add New Definitions to Section 200-53, Definitions.
- 3. Amending Section 200-18, GB General Business District, of the Zoning Law Regarding Permitted Uses, Setbacks and Landscape Requirements, and Amending Section 200-33 of Article VI, Affordable Housing of the Zoning Law as it pertains to the GB District.
- 4. Amending the Zoning Law and Zoning Map to Create a Multifamily-Inn (MF-I) Zoning District and to Place a Certain Property on Hawkes Avenue into the New District.
- 5. Amending the Town Zoning Law and Zoning Map to Change ORM Office-Research Manufacturing District to an O-RB Office-Research Business District, to create a new O-RE Office-Research Education District, and to Place a Certain Property Located on Executive Boulevard into the New O-RE District.
- 6. Amending the Zoning Law to add Maximum Height for Fences in Rear Yards.

#### **MISCELLANEOUS**

**589** North State Road Mr. Weeks asked the Board for input on a recent inquiry of possible development of a Dog Care Facility. This site is currently Taconic Cut Stone. As discussed at earlier meetings, the nature of the proposal seems to be an upscale dog care facility, which offers grooming, massage, hydro-therapy, outdoor play and run areas and overnight stays. The Board agreed that an interpretation of this use by the Zoning Board of Appeals is necessary. The property is located in the GB General Business Zone.
