The Applicant, Parth Knolls, LLC, is <u>resubmitting</u> its comments of December 7th, in response to the draft resolutions referred to below, and has included the revisions as discussed at the Planning Board meeting of December 7, 2016, for the Planning Board's review and adoption at their meeting on December 21, 2016.

1. Resolution of Site Plan Approval. Draft 12-6-16:

- a) Page 4, paragraph 1.b. and 1.c:
 - 1. <u>Eliminate</u>. Applicant hereby request that <u>paragraphs numbers 1.b. and 1.c</u> be eliminate as the provisions stated in these paragraphs have they been previously responded to and approved.
- Add new paragraph in this section, pertaining to the Memorandum dated December 7, 2016, from John Hamilton Building Inspector, Town of Ossining Building Department, stating that: based on my review of the Site Plan and the Recreation Plan, the project is in conformance with the Town of Ossining Zoning Code; and
 - 1. <u>Insert</u> the drawing number C-113, into the list of drawings, titled Recreation Plan, last revision date 12.7.16, a copy of which the Board received on December 7, 2016
 - c) Page 4, last paragraph:

1. <u>Insert</u> the date of December 21, 2016 for the Public Hearing to be closed, as was agreed to at the December 7, 2016 Planning Board meeting; and

Insert. Recreation Fee. The Planning Board has determined that a reasonable and prudent Recreation Fee, due from the Applicant for 53 apartments, shall be in the total amount of \$178,000.50; and

The Recreation fee will be prorated and will only become due and payable to the Town of Ossining, by the Applicant, as, if, and when a Certificate of Occupancy is issued and received by the Applicant, for each apartment, in the amount of \$3,358.50 per apartment; and
