**I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL**

The Regular Meeting of the Town Board of the Town of Ossining was held on July 23, 2019 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Northern Wilcher Jr., Jackie G. Shaw, Elizabeth R. Feldman and Gregory G. Meyer. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Madeline Zachacz, and Confidential Secretary Victoria Cafarelli.

**II. PUBLIC HEARINGS IN THE MATTER OF** *Visitors shall be accorded one (1) four (4) minute opportunity to speak on each public hearing.*  
**\*TO BE HELD CONCURRENTLY**

At 7:32 p.m., the Public Hearing opened.

Supervisor Levenberg stated that we will be re-opening five public hearings, the first three of which pertain to the three referenda the Town Board is considering putting on the ballot for the November election, which will ask Ossining voters to contemplate changing the ELECTED offices of Superintendent of Highways, Receiver of Taxes and Town Clerk to appointive offices. Two questions that routinely are asked: Why these positions, and why now? In response to the first, Why these positions, the answer is simply: we are small. Between the Town General functions, and the Unincorporated Town, we only employ around 60 people. Every time we have a changeover in staff, we slow down and consider how to move forward—do we fill the same job? Do we make a full time job part time, or vice versa? Is this a job we can share with one of our Villages or have performed through an IMA? We are treating these positions the same as we do for every other role in the Town so that we can stay agile and address the immediate needs of our residents, rather than submitting a roll-over budget and never questioning staffing levels, re-visiting programmatic needs, or reallocating funds to areas of need. And that brings me to the second question, Why now? This year, we are in a position to look at two of three positions because of a recent or pending retirement. Particularly in jobs at the department head level, which tend to command higher salaries than our unionized staff, we are always on the lookout for the flexibility to share responsibilities and allocate resources more effectively. The fact that two of these three positions have been (or will soon be) vacated by long term incumbents underscores the importance of the process we usually take when considering vacancies. We are looking at this now because the opportunity has presented itself and we think it's worth discussing. The Town Board is merely suggesting a community wide vote. If you think this is a terrible idea, I urge you to come to the polls and tell us so. If you think it's a fantastic idea, I urge you to come to the polls and tell us so. If you are still on the fence, I urge you to learn more.

- **Local Law #4 of 2019 – Abolishing the office of Elective Town Superintendent of Highways and creating the office of Appointive Town Superintendent of Highways subject to a mandatory referendum\***

**At 7:40 p.m., Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the Public Hearing be adjourned until August 6, 2019.**

**At 7:32 p.m., the Public Hearing opened.**

- **Local Law #5 of 2019 – Abolishing the office of Elective Town Receiver of Taxes and creating the office of Appointive Town Receiver of Taxes subject to a mandatory referendum\***

**At 7:40 p.m., Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the Public Hearing be adjourned until August 6, 2019.**

**At 7:32 p.m., the Public Hearing opened.**

- **Local Law #6 of 2019 – Abolishing the office of Elective Town Clerk and creating the office of Appointive Town Clerk subject to a mandatory referendum\***

**Town Counsel Christie Tomm-Addona explained that if the Board were to adopt the local laws they would have to do so more than 60 days before the November election so that we are in compliance with the general municipal law and municipal home rule law. By the end of August, the Board will have to close the Public Hearing and vote on the local laws in order to be within the more than 60 days time frame before the November 5<sup>th</sup> election. The Public Hearing had been opened since February.**

**No one from the public came to speak on these local laws.**

**At 7:40 p.m., Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the Public Hearing be adjourned until August 6, 2019.**

**At 7:32 p.m., the Public Hearing opened.**

- **Local Law #7 of 2019- Amendments to Chapter 74 of the Town Code entitled “Dogs” to Regulate Registration for and Use of the Town’s Dog Parks.**

**Supervisor Levenberg stated that based on the feedback received some changes were made to the draft of the local law. The Town will be placing dog signs in Cedar Lane Dog Park and Ryder Park Dog Run in an effort to encourage residents to provide feedback on the proposed local law.**

**Town Counsel Christie Tomm-Addona elaborated on the changes being made to the draft of local law #7. Concerns have been raised over the extra registration fee that residents in the Unincorporated Town, Village of Ossining, and Village of Briarcliff Manor that belong to the Town of Ossining are paying. The draft of local law #7 is being revised to address these concerns. We are still waiting to get more feedback from interested groups that have been reached out to regarding this law. We are specifically waiting to get feedback from the Village of Ossining and Village of Briarcliff Manor. One of the items the Town wants to discuss with the Village of Ossining is the possibility of the Village going on to the same licensing schedule that the Town is on. Local law #7 is intending to have dog licensing run June 1<sup>st</sup> of each year until May 31<sup>th</sup> of the following year. During that time period there will be a different colored tag that will be given to each dog during the registration period, thus making it easier to identify whether or**

not a dog has been properly registered. If there is a different scheduling for when the licenses have to be issued it could make it difficult to identify what dogs have been properly registered since everyone wouldn't have their dog tags at the same point in time.

Councilmember Wilcher questioned why the dog tags wouldn't be plastic. Councilmember Feldman explained that feedback received had revealed that plastic dog tags break before the year. Town Counsel Christie Tomm-Addona stated that they would consider other type of materials to make the dog tags out of.

No one from the public came to speak on these local laws.

At 7:52 p.m., Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the Public Hearing be adjourned until August 6, 2019.

At 7:40 p.m., the Public Hearing opened.

- **Increase and Improvement of Facilities of Consolidated Sewer District In the Town of Ossining, Westchester County, New York**

Supervisor Levenberg explained that the Town is looking to borrow \$100K to make improvements to our Sewer District, specifically with regards to lift station generator replacement. The lift stations play a critical role in our sanitary sewer systems. Operating generators ensure that should power go off line to these machines, there is a backup in place so our sewer system can continue to operate. Our Highway Superintendent and Engineering team are currently surveying which generators are in most urgent need of replacement, and we can expect to purchase between 3 and 4 new generators with these funds. As we have used some of our fund balance in this District already this year to purchase replacement pumps, we were advised that bonding was the best way to go to initiate this next phase of upgrading our system.

Town Comptroller Tom Warren spoke about the bond and noted that there would not be a permissive referendum on it as a result of it involving special districts.

Superintendent of Highways Pete Connolly spoke about the use of generators for lift stations and the need for new ones.

Supervisor Levenberg discussed how backup generators help to repower pumps and lift stations after they fail during electrical surges. At times it does not work, but without backup generators it would be more likely that a pump failure will last for a longer period of time. Current generators are aging and need to be replaced.

No one from the public came to speak on this bond.

At 8:04 p.m., Councilmember Shaw moved and it was seconded by Councilmember Wilcher that the Public Hearing be closed.

At 7:52 p.m., the Public Hearing opened.

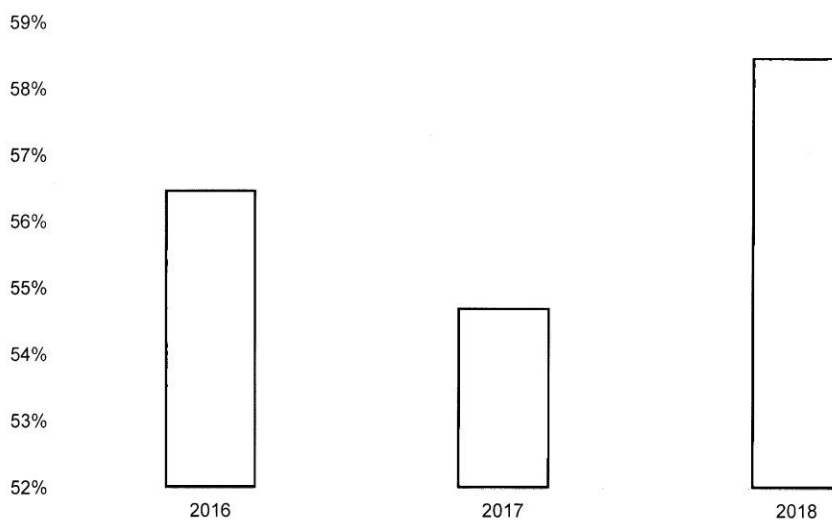

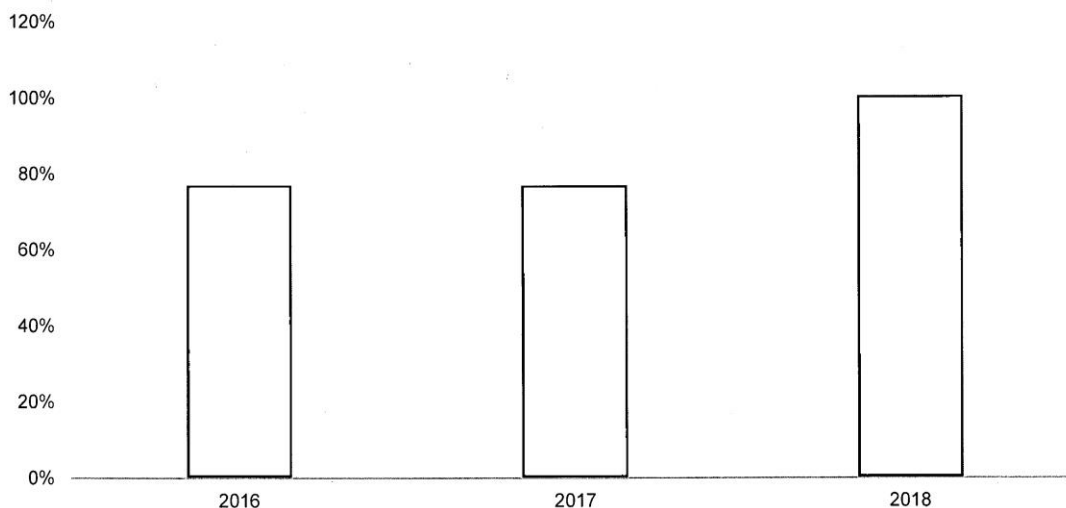

## Other Considerations

- Highway Fund (pages 74-76) – remains strong, although ended the year with expenditures that exceeded revenues by \$349,794 resulting in ending fund balance of \$727,747 of which \$696,310 is considered assigned for highway purposes. (Assigned Fund Balance \$693,310/\$2,639,604-adopted 2019 Highway Budget = 26.3%.)
- Special Districts Fund – (pages 78-81) – is trending positively. Ended the year with expenditures that exceeded revenues by \$19,017 resulting in ending fund balance of \$913,866.
- Capital Projects Fund (pages 82-85) - Approximately 22 active projects. Fund deficit of \$962,590, supported by \$2,202,791 in bond anticipation notes outstanding.

## Other Considerations (Cont'd) Significant Accounting estimates

- Implemented Government Accounting Standards Board (GASB) Statement No. 75** "Accounting and Financial reporting for Postemployment Benefits Other than Pensions" (OPEB).

No funding mechanism in place in NYS.

Actuarially determined liability at December 31, 2017 = \$6.5 million. New Pronouncement implemented this year which increased the liability to close to \$15 million, inclusive of a **cumulative effect of change in accounting principle of \$9.2 million.**

The Town funds this on a pay-as-you go basis with annual contributions of approximately \$500,000 (Page 51).

- Pension reporting (pages 46-50) reflects ERS system being funded at 94.7%, thus creating a liability of \$346,270 (the Town's proportionate share) at a discount rate of 7%.

## **VI. DEPARTMENTAL REPORTS**

- Superintendent of Highways Pete Connolly gave the board an update on the Highway Department. Mechanics have begun the replacement of rotted truck body number 56. This vehicle will only be used during the winter months. By doing repairs in-house the Town has saved approximately \$30,000. The Highway Department additionally repaired storm drainage pipes along Samstag Avenue,

Old Albany Post RD, Minkle RD and Tappan Terrace over the past couple months. Sewer pumps burned out at White Tail Circle and Mystic Point. A backup pump was used while an electrician replaced the damaged circuit panels. The pump at Mystic Point will be repaired while the one at White Tail Circle will not due to its age. Installation of screening at two pump stations at Parker Bail and Yes Turn has begun. Over the next couple of months the Highway Department will be replacing 950 feet guardrail throughout the Town.

- Superintendent of Cemeteries Pete Connolly gave the board an update on the Cemetery Department. There have currently been 34 interments in Dale Cemetery since January. Last month there was 1 interment in Sparta Cemetery and Revolutionary RD. All current monument foundations orders are up to date. The Austin Historical Cemeteries Conservancy purchased two new park benches and a tree that was planted in Section 5. Whenever possible we work together with the Park Department in maintaining the cemetery grass. The Cemeteries Department will continue working on our yearly tree trimming and working on a return date for the monument preservation company to come back and fix broken older monuments.

**E. Resolution Authorizing The Supervisor To Apply For And Receive Funding Under The 2019 Department Of State – Local Waterfront Revitalization Program**

WHEREAS, the Town of Ossining Town Board has caused the preparation of a Department of State Local Waterfront Revitalization Program Grant Application to be prepared and supports the submittal of the application to the New York State Department of State; and

WHEREAS the Project shall be titled “Town of Ossining Local Waterfront Revitalization Project and Louis Engel Waterfront Park Master Plan” and include a grant narrative, work plan, and other supporting documents necessary for submission of the application; and

WHEREAS should funding from the New York State Department of State be awarded, such state assistance shall not exceed 75% of the total eligible project costs set forth in the application or 85% of the total eligible project costs in an environmental justice community; and

WHEREAS the Louis Engel Park is located entirely in an environmental justice area and the Town is committed to focusing on improving the environment and addressing disproportionate adverse environmental impacts that may exist in this area of the Town; and

WHEREAS the Town Council is hereby committed to using municipal funds and in-kind services as a local match in accordance with the requirements of NYS Environmental Conservation Law §54-1101 and NYS Executive Law §42-918 for an amount up to fifteen percent (15%) of the total project cost or twenty-five percent (25%) of the total project cost should the New York State Department of State not deem the project to benefit and serve the environmental justice area population; and

NOW THEREFORE BE IT RESOLVED by the Town of Ossining Town board that the Town shall hereby apply to the Department of State for the Local Waterfront Revitalization Program Grant Funds; and

BE IT FURTHER RESOLVED, that the Supervisor is hereby authorized and designated as the representative and to act as such in connection with the application to provide additional information as may be required including all understandings and assurances contained in the application; and

BE IT FURTHER RESOLVED, that the Supervisor is hereby authorized and directed to execute any contract and/or agreement with the NYS Department of State upon grant award in connection with the Application and her designee is further authorized to request funds from the NYS Department of State pursuant to said contract and/or agreement; and

BE IT FURTHER RESOLVED, to the extent all or any actions hereby authorized have been executed and/or performed by the Supervisor all are hereby ratified and confirmed and this Resolution take effect immediately.

**Whereas, the Town Board of the Town of Ossining hereby pledges to participate in the “Climate Action Planning Institute Westchester County” project that will be submitted as a grant proposal to the New York State Climate Smart Communities Grant Program by Westchester County as lead applicant; and**

**Whereas, the Town of Ossining hereby pledges to participate in this climate action planning leadership program, in partnership with the Hudson Valley Regional Council and ICLEI – Local Governments for Sustainability; and**

**Whereas, the Town of Ossining certifies that it has identified and secured a minimum of \$11,007 in matching funds from donated professional services from the Town staff and volunteer time from Green Ossining/Climate Smart Communities Task Force and Town of Ossining Environmental Advisory Committee as contribution to the “Climate Action Planning Institute Westchester County” project, pursuant to the requirements of Environmental Conservation Law Article 54 Title 15, the balance of the match needed to meet the NYSDEC CSC grant requirement of 50% for this project will be contributed by Westchester County and other participating Westchester County municipalities; and now**

**Therefore, be it resolved, that the Town Board of the Town of Ossining hereby authorizes the Supervisor to act on its behalf for submittal of a letter of commitment for matching funds provision and participation in Westchester County’s “Climate Action Planning Institute Westchester County” application to the Consolidated Funding Application.**

**G. Non-Agricultural Nonpoint Source Planning Grant Program – Beach Restoration Louis Engel Park**

**Whereas, the Town of Ossining owns parkland at Westerly Road, Louis Engel Park; and**

**Whereas, Louis Engel Park has many park amenities available to the community, including an access point to the Hudson River at the beach; and**

**Whereas, swimming has not been allowed at the Louis Engel Park beach for many years and there is community interest in re-opening the beach to swimming, requiring planning and parks improvements to address issues related to water quality, rising sea levels, and increased flooding and restore the beach; and**

**Whereas, funding is available through the New York State Department of Environmental Conservation Division of Water’s Non-Agricultural Nonpoint Source Planning grant program to fund beach restoration planning projects under the Consolidated Funding Application; now therefore be it**

**Resolved, that the Town Board of the Town of Ossining authorizes the submission of a grant application to the Non-Agricultural Nonpoint Source Planning grant program under the Consolidated Funding Application to complete a feasibility study and beach sanitary survey at the Louis Engel Park Beach; and**

**Be it further Resolved, that the Town Board of the Town of Ossining commits matching funds in the form of cash match as required by the Non-Agricultural Nonpoint Source Planning grant program.**

**H. Resolution In Support Of Us Coast Guard Appropriations Bill To Put A Temporary Ban On The Establishment Of Anchorages Along The Hudson River**

Councilmember Shaw moved and it was seconded by Councilmember Feldman that the following resolution be approved.

WHEREAS, many cities, towns and villages along the Hudson River in New York, from Yonkers to Albany, have expressed concerns about the U.S. Coast Guard's ongoing review of requests to establish a number of permanent anchorages along the Hudson River; and

WHEREAS, the U.S. Coast Guard, in order to have a formal process to review these proposals with representatives of industry, of commerce and government, established a Ports And Waterways Safety Assessment (PAWSA) process; and

WHEREAS, as an ongoing review of that process, the Hudson River Safety Navigation Operations Committee, which is an offshoot of the PAWSA process, has been reviewing related Coast Guard activities; and

WHEREAS, the Hudson River Safety Navigation Operations Committee circulated information with regard to the U.S. Coast Guard Appropriations Bill in Congress, noting that Section 420 includes a temporary blanket prohibition on the establishment of all anchorages in the Hudson River from Yonkers north to Kingston; and

WHEREAS, while the provisions of this bill do not mean that in the event of an emergency a tug or commercial vessel cannot ask for an emergency anchor, but basically prohibits the Coast Guard from establishing any formal, designated anchorage areas within this area, and would establish a temporary blanket prohibition of all formally designated anchorage areas in the Hudson River from Yonkers north to Kingston;

NOW, THEREFORE, BE IT RESOLVED that the Town of Ossining does hereby express its support for the U.S. Coast Guard Appropriations Bill in Congress, noting that Section 420 includes a temporary blanket prohibition on the establishment of all anchorages in the Hudson River from Yonkers north to Kingston, so that the U.S. Coast Guard, the Hudson River Safety Navigation Operations Committee, and all involved and affected parties, may work cooperatively and have a thorough and methodical process for the formal establishment of anchorages on the Hudson River between Yonkers and Kingston, NY.

WHEREAS, at a meeting of said Town Board duly called and held on July 9, 2019, an order was duly adopted by it and entered in the minutes specifying the said Town Board would meet to consider the increase and improvement of the facilities of the Consolidated Sewer District in said Town at a maximum estimated cost of \$100,000

and to hear all persons interested in the subject thereof concerning the same at 86-88 Spring Street, in Ossining, New York, in said Town, on July 23, 2019, at 7:52 P.M., Prevailing Time; and

WHEREAS, said order duly certified by the Town Clerk was duly published and posted as required by law; and

WHEREAS, a public hearing was duly held at the time and place set forth in said notice, at which all persons desiring to be heard were duly heard; NOW, THEREFORE, BE IT

ORDERED, by the Town Board of the Town of Ossining, Westchester County, New York, as follows:

**Section 1.** Upon the evidence given at the aforesaid public hearing, it is hereby found and determined that it is in the public interest to make the improvement, to increase and improve the facilities of Consolidated Sewer District in the Town of Ossining, Westchester County, New York, consisting of the purchase of generators for lift stations, including costs incidental thereto, at a maximum estimated cost of \$100,000.

**Section 2.** This order shall take effect immediately.

**J. A Resolution Authorizing The Issuance Of \$100,000 Serial Bonds Of The Town Of Ossining, Westchester County, New York, To Pay The Cost Of The Increase And Improvement Of The Facilities Of The Consolidated Sewer District In The Town Of Ossining, Westchester County, New York.**

Councilmember Shaw moved and it was seconded by Councilmember Wilcher that the following resolution be approved.

WHEREAS, pursuant to the provisions heretofore duly had and taken in accordance with the provisions of Section 202-b of the Town Law, and more particularly an order dated July 23, 2019, said Town Board has determined it to be in the public interest to increase and improve the facilities of Consolidated Sewer District in the Town of Ossining, Westchester County, New York, at a maximum estimated cost of \$100,000; and

WHEREAS, it is now desired to provide funding therefor; NOW, THEREFORE, BE IT

RESOLVED, by the Town Board of the Town of Ossining, Westchester County, New York, as follows:

**Section 1.** For the class of objects or purposes of paying the cost of the increase and improvement of the facilities of Consolidated Sewer District in the Town of Ossining, Westchester County, New York, consisting of the purchase of generators for lift stations, including costs incidental thereto, at a maximum estimated cost of \$100,000, there are hereby authorized to be issued \$100,000 serial bonds of said Town pursuant to the provisions of the Local Finance Law.

**Section 2.** It is hereby determined that the maximum estimated cost of the aforesaid class of objects or purposes is \$100,000 and that the plan for the financing thereof is by the issuance of the \$100,000 serial bonds of said Town authorized to be issued pursuant to this bond resolution.

**Section 3.** It is hereby determined that the period of probable usefulness of the aforesaid objects or purposes is thirty years, pursuant to subdivision 4 of paragraph

a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

**Section 4.** Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

**Section 5.** The faith and credit of said Town of Ossining, Westchester County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such obligations as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. To the extent not paid from other sources, there shall be annually assessed upon all the taxable real property within said Consolidated Sewer District in the amounts and in the manner provided by law an amount sufficient to pay the principal and interest on said bonds as the same become due, but if not paid from such source, all the taxable real property in said Town shall be subject to the levy of ad valorem taxes sufficient to pay the principal of and interest on said bonds as the same shall become due.

**Section 6.** Such bonds shall be in fully registered form and shall be signed in the name of the Town of Ossining, Westchester County, New York, by the manual or facsimile signature of the Supervisor and a facsimile of its corporate seal shall be imprinted or impressed thereon and may be attested by the manual or facsimile signature of the Town Clerk.

**Section 7.** The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as he or she shall deem best for the interests of the Town.

**Section 8.** All other matters, except as provided herein relating to such bonds, including determining whether to issue such bonds having substantially level or declining debt service and all matters related thereto, prescribing whether manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bonds are to be executed in the name of the Town by the facsimile signature of its Supervisor, providing for the manual countersignature of a fiscal agent or of a designated official of the Town), the date, denominations, maturities and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the Supervisor.

**Section 9.** The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

- 3) Such obligations are authorized in violation of the provisions of the Constitution.

**Section 10.** This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

**Section 11.** This resolution which takes effect immediately shall be published in summary in the official newspaper of the Town, together with a notice of the Town Clerk in substantially the form provided in Section 81 of the Local Finance Law.

**J. Permission to Serve Alcohol at Town of Ossining Summer Concert Series-  
Brimstone Hill Vineyard**

Resolved that the Brimstone Hill Vineyard is hereby authorized to operate a wine tasting during the Summer Concert Series event held on July 26th, at the Louis Engel Waterfront Park in the Town of Ossining and serve for consumption by persons over 21 years of age, Brimstone Hill Vineyard wine; and

Be it further Resolved, that the Brimstone Hill Vineyard will also obtain all necessary permits including an event permit and/or marketing license from the New York State Liquor Authority and will provide proof of insurance and the letter of indemnity to the Town in a form acceptable to Counsel to the Town.

**K. Resolution – Calling for Public Hearing on Local Law #     of 2019 – Amendments to Chapter 180 of the Town Code entitled “Taxation” to Implement the “Solar Energy System PILOT Law of the Town of Ossining, New York.”**

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

WHEREAS, New York Real Property Tax Law § 487 provides for an exemption of the value of a solar panel system from local property taxes, the intention of which is the State’s efforts to meet its clean energy goals by providing economic incentives for solar systems; and

WHEREAS, RPTL § 487 also allows taxing jurisdictions to opt out of the tax exemption, making the added value of the solar panel system fully taxable; or alternatively, if the taxing jurisdiction does not opt out of the exemption, the taxing jurisdiction can require a solar developer to pay an annual fee or “payment-in-lieu of taxes” as a replacement for the taxes it would have otherwise collected, so long as the PILOT does not exceed what the taxes would have been without the exemption; and

WHEREAS, recognizing that a balance is needed to encourage clean energy within the Town while still ensuring the property owner pays its fair share of taxes, the Town Board desires to adopt a local law to implement a formulaic, jurisdiction-wide PILOT agreement process with solar developers and property owners; and

**NOW THEREFORE,**
