**I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL**

The Regular Meeting of the Town Board of the Town of Ossining was held on December 13, 2011 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Catherine Borgia. Members of the Board present were: Councilmembers Geoffrey Harter, Northern Wilcher, Peter Tripodi and Michael Tawil. Also present were Town Attorney Wayne Spector, Budget Officer Madeline Zachacz and Town Clerk Mary Ann Roberts.

**II. Public Hearing- in the matter of Traffic Violations Bureau Local Law No. 9 of 2011**

At 7:32 P.M., the Public Hearing was opened.

Town Attorney Wayne Spector stated that with the upcoming Court Consolidation, the Village of Ossining Court will be abolished as of December 31, 2011 and the Traffic Violations Administrative function will still be under the Town Court. The Village will pay the Town for the Administrative staff for non-moving violations, which is mainly parking violations.

Bobby Williams, Spring Street, questioned whether the Town was collecting money for the Village. What other purpose will it serve?

Supervisor Borgia responded that there is a particular software system. The IMA will pay for running the traffic violations. It will not be a duplication of services. Town Attorney Spector responded that there will only be one court. Justice has direct responsibility of the monies going to the correct entity (Village/Town/State) portion.

At 7:43 P.M., the Public Hearing was closed.

**Public Hearing- in the matter of Emergency Alarms in the Town of Ossining Local Law No. 10 of 2011**

At 7:43 P.M., the Public Hearing was opened.

Town Attorney Wayne Spector provided an overview of this local law. It will bring up to date the list of Alarm Monitoring Companies. It will allow for certain applications with a registration fee. The Town will be in tune with the majority of municipalities in the County of Westchester.

Supervisor Borgia added that definitions will be changed. This process began in the Town Police Department and has now been transferred to the Supervisor's office. The fees have been pulled out of the local law and will be put into the fee schedule

which will be adopted in January at the Re-organizational Meeting. This will make the false alarm fees clearer.

Councilman Tripodi questioned the fees for penalties and whether it was yearly. Supervisor Borgia responded that if you receive a \$250 fine it is better to register your alarm for \$25 rather than pay the \$250. The first two false alarms are freebies and then if there are additional ones, the fine is imposed. The registration is from the residents, not the alarm companies. It is useful for municipalities to know where alarms are located.

Steve Penzuk, Total Protection, Lincoln Place, questioned the registration of alarm companies. He has been in the business for the past 25 years and maintains that State Law exempts alarm companies.

At 7:53 P.M., the Public Hearing was closed.

- Optimum life path for the Westchester County Police. This is normal to pay this amount to the Westchester County Police.
- Found a Medicare reimbursement for someone who has passed away which is indicated on page 6 on the Voucher Detail.
- What is the status the Art instructor and Dance instructor for the Senior Center? Do we have any volunteers for these positions? This would enable us to cut costs on these two positions.
- The receipt for the canopy tent was \$419. What kind of tent was purchased? Mr. Tripodi did some research on-line and found the same types of tents and the highest for \$270 and the least expensive was \$120 and the one we purchased was \$419.

Supervisor Borgia advised that the tent that the cemetery purchased was specialized and more of a protective tent.

**F. Approve 2012 Budget**

Councilmember Harter moved and it was seconded by Councilmember Tawil that the following be approved:

Resolved, that the Town Board of the Town of Ossining hereby approves the 2012 Budget for the Town of Ossining. Total appropriations for the 2012 entire Town (10) Fund are \$5,292,022. Total appropriations for the Unincorporated (20) Area Fund are \$3,672,145 and total appropriations for the Highway (31) Fund are \$2,207,249. Total appropriations for the Water and Sewer Funds are \$469,929. Total appropriations for the Fire/Light/Refuse Funds are \$1,213,020. Total appropriations for the Ambulance District are \$536,728.

Supervisor Borgia commented on this year's budget and thanked everyone who participated in this budget. This year the budget was complex and we had to be creative, work with the court consolidation and the 2% tax cap. We were pleased that all of our Manager's were able to bring in very tight budgets this year. Supervisor Borgia thanked her colleagues who spent many hours working on this budget. We also were able to create this budget while we were also creating a fund balance. The Town is in excellent financial shape.

Councilman Tripodi had the following statements:

- The Town outside does not have Fire Protection. Why wasn't the Board informed?
- Lack of open meetings for the Mid- Hudson Ambulance District and not advertising these meetings. There are personnel issues that exists in OVAC. However, the service is excellent. There could be serious consequences ahead. This issue has not been properly delt with.
- The Police Station on North State Rd. should be sold or rented.

- Court Consolidation has failed already and it has not even begun. Court Consolidation is costing \$460,000 in new spending for the Town of Ossining.
- Finance Department is costing the Town \$360,000 and would like to examine this IMA.
- All employees of the Town Of Ossining receive training to help them perform their jobs better paid for by the Town except for the Town Board members. Mr. Tripodi feels that this is directly aimed at him.

Councilman Tripodi will not be voting for this resolution.

Supervisor Borgia commented on the following:

- It is true that The Town does pay for some training. We discuss every year what our expenses will be.
- We have already reviewed the Finance IMA.
- Court Consolidation-the Comptroller's office did review our Court Consolidation and did give the Town a credit of \$460,000 this is equivalent to the amount of savings that the Village budget sees under the Court Consolidation.
- Police Station-The new board will be looking at new ways of using this property for the municipality.
- Mid-Hudson Ambulance District-this is governed by an oversight committee. These meetings are advertized.
- Fire protection – The Town has a contract with the Village of Ossining for fire protection.

Councilman Harter stated that this budget is a major accomplishment and congratulated the Supervisor and her staff.

Councilman Wilcher stated that the Board has discussed Mr. Tipodi's points over and over again. Councilman Wilcher thanked the Supervisor and her office for the work they have done on the budget.

Councilman Tawil stated that the Town has passed two consecutive tax cuts and increased their fund balance. He is proud of this accomplishment.
