I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on March 22, 2016 at the Birdsall-Fagan Police Court/Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana Levenberg. Members of the Board present were: Councilmembers Elizabeth R. Feldman, Kim L. Jeffrey and Northern Wilcher, Jr. Also present were Town Counsels Steven Silverberg and Christie Tom Addona, Budget Officer Madeline Zachacz and Town Clerk Mary Ann Roberts.

Supervisor Levenberg read the following statements:

Good evening, and welcome to the March 22^{nd} Town Board Meeting of the Town of Ossining. Please stand for the pledge.

We have just a few items on our agenda this evening, but I'd like to start with some reminders for the coming week.

Friday, March 25th, is the last day to register if you plan to vote in the New York State primaries. Whoever you decide to cast your vote in favor of this year in the many elections at the local, state and federal level, please avail yourself of the opportunity to do just that. So many people have fought to give us this right, and the least we can do is exercise it.

This Thursday evening, the Ossining Lions will be hosting an exciting dinner meeting at the Elks Lodge, where the topic will be "The Business of Art". Some of our local experts will be on hand to guide the conversation, including Ossining Arts Council President Mark Sarazen, Theater O Artistic Director Jessica Irons, and jazz musician Ted Daniels. As many of our residents observe Good Friday this week, we want to give a heads up about the traffic around the Village of Ossining on Friday evening. The procession begins and ends at St. Ann's Church on Eastern Avenue, but will be going down Wolden Road to Maurice, across Route 9 and down Edward to Washington, up Spring Street to Main Street, and finally to Ellis Place. The procession kicks off at 5:30PM and will last for several hours, so please plan accordingly as you head home for the evening.

E. Adoption of Local Law #3 of 2016- Veteran's Exemption Adjustment

Councilmember Jeffrey moved and it was seconded by Councilmember Wilcher that the following be approved:

WHEREAS, the Town Board of the Town of Ossining has been considering the adoption of a proposed local law entitled "Veteran's Exemption Adjustment", which shall cause an adjustment of current Veteran's Exemptions levels in connection with the new values following the Town-wide revaluation"; and

WHEREAS, in accordance with New York State Law, and after having provided all requisite notice thereunder, the Town Board conducted a Public Hearing on Introductory Local Law No. 3-2016 entitled "Veteran's Exemption Adjustment" on March 8th at 7:40 p.m.at the Birdsall/Fagan Police Court Facility, 86-88 Spring Street, Ossining, New York during which the public had the opportunity to be heard on such proposed local law; and

WHEREAS, the proposed Local Law is a Type II action and does not require environmental review;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Ossining hereby adopts Local Law No. 3-2016, entitled "Veteran's Exemption Adjustment" with such adoption to take effect as set forth in said Local Law and as otherwise required by law; and

BE IT FURTHER RESOLVED, that the Town Board directs said Local Law #3 of 2016 to be filed and/or distributed in accordance with applicable law.

F. Local Law #5 of 2016- Creating a New Type I List for Actions Under SEQRA: Referral to Town Planning Board

Whereas, the Town of Ossining is considering a local law to repeal Chapter 85 of the Town Code in favor of the State regulations for SEQRA processes, but wishes to creates a list of Type I Actions to append to the New York State Law as it applies in Ossining so as to maintain the current level of environmental protection; and

Whereas, Town Counsel has recommended such changes, and has recommended that the Town Board also seek input from various agencies on this change;

Therefore be it Resolved that the Town Board hereby refers the draft Local Law #5 of 2016 to the Town Planning Board for review and comment.
