I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL

The Special Meeting of the Town Board of the Town of Ossining was held on June 20, 2017 at the Ossining Municipal Building, 16 Croton Avenue-1st Floor Board Room, Ossining, NY. The meeting was called to order at 9:06 p.m. by Supervisor Dana Levenberg. Members of the Board present were: Councilmembers Kim Jeffrey, Northern Wilcher, Elizabeth R. Feldman and Karen D'Attore. Also present were Town Counsel Christie Tom Addona and Budget Officer Madeline Zachacz.

B. Resolution- Consulting Agreement: Stephen Tilly, Architect

Councilmember Wilcher moved and it was seconded by Councilmember D'Attore that the following be approved:

Resolved, that he Town Board of the Town of Ossining hereby authorizes the Supervisor to sign a revised agreement for design and consulting services with Stephen Tilly Architect entitled "Preservation and Restoration of the Exterior of the Superintendent's Cottage at Dale Cemetery, 104 Havell Street, Ossining NY 10562", dated June 15th, 2017, and subject to approval by Counsel to the Town as to form.

C. Resolution Authorizing Acceptance and Installation of Two Little Free Library Boxes

Councilmember Jeffrey moved and it was seconded by Councilmember Feldman that the following be approved:

WHEREAS, Little Free Library is a company that creates boxes and other structures for the intended purpose of creating a publicly accessible location for books to be donated, borrowed, exchanged and returned by members of the public, and

WHEREAS, a private individual donated two such boxes to the Ossining Union Free School District ("School District"), and

WHEREAS, the School District has offered to donate the boxes to the Town of Ossining to be installed on Town property and used for their intended purpose, and

NOW THEREFORE,

BE IT RESOLVED, that the Town Board authorizes the Town to accept the donation of the two Little Free Library boxes from the School District, and

BE IT FURTHER RESOLVED, that the boxes will be used for their intended purpose so long as they are structurally capable of doing so and do not present a hazard to the public, and

BE IT FURTHER RESOLVED, that one of the boxes will be placed in Engel Park and the other box will be placed in Ryder Park, with the exact locations within each park to be approved by the Supervisor in consultation with the appropriate Town staff.

D. Approval—Fire Inspection Dinner at Louis Engel Park

Councilmember Jeffrey moved and it was seconded by Councilmember Feldman that the following be approved:

Resolved, that the Town Board of the Town of Ossining hereby authorizes the use of Louis Engel Park by the Ossining Fire Department for their annual Inspection Dinner on Saturday, June 24th 2017 between the hours of 4PM and 12 midnight; and

Be it further Resolved, that the Town Board does hereby waive the permit fee for this event provided that all material to issue the permit is in order.
