The Special Meeting of the Town Board of the Town of Ossining was held on January 17, 2018 at the Ossining Municipal Building, 16 Croton Avenue-1<sup>st</sup> Floor Board Room, Ossining, NY. The meeting was called to order at 8:30 p.m. by Supervisor Dana Levenberg. Members of the Board present were: Councilmembers Kim Jeffrey, Northern Wilcher, Karen D'Attore, Elizabeth R. **Supervisor Levenberg announced the following:** 

On Thursday, January 18<sup>th</sup>, the Ossining Documentary and Discussion Series will be hosting a screening of "Room to Breathe" at the Ossining Public Library. The film follows a classroom of troubled middle school students in San Francisco and examines how the age-old practice of mindfulness works when applied to the learning environment. This looks like it is going to be a fascinating film and panel discussion—I hope you can join us in the Budarz Theater on Thursday, the film begins at 6:30PM. # A. Town Arborist- Appointment

Councilmember D'Attore moved and it was seconded by Councilmember Wilcher that the following be approved:

Resolved, that the Town Board hereby appoints Craig A. Stevens, Peekskill, as the Town Arborist for 2018; and

Be it Further Resolved, that Mr. Stevens' rate of \$50 per tree will be paid out of the applicant's tree removal permit fee.

Supervisor Levenberg stated that as part of our Tree Protection law, the Town must appoint and contract with a certified arborist in order to make determinations about the health of trees. Mr. Stevens will review all tree removal permits applications and give recommendations on whether the application should be accepted, altered or rejected. The fee paid to Mr. Stevens will be absorbed in the cost of the permit application.

# **B.**Board of Assessment Review- Appointment

# H. Resolution of Support—Ossining Children's Center, State Street Location

Councilmember D'Attore moved and it was seconded by Councilmember Feldman that the following be approved as amended:

WHEREAS, the Ossining Children's Center (OCC) has been providing high quality child care and education to the community for more than 120 years;

WHEREAS, OCC provides children with a strong foundation for success in school and adult life;

WHEREAS, OCC empowers working parents in their roles as breadwinners and as their children's most important teachers;

WHEREAS, OCC provides families with support and stability, and – in doing so – strengthens the entire community;

WHEREAS, OCC seeks to build a new Center at 32 State Street, which will expand OCC's model Infant and Toddler program, strengthen OCC's partnership with the Ossining Public Schools, integrate all of its programs under one roof, provide working families with a more convenient and family-friendly location; and provide our community's children with a wonderful preschool and after-school environment;

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Ossining endorses the Ossining Children's Center's goal to build a new child care and education center at 32 State Street, Ossining.

Supervisor Levenberg stated that as we discussed in our Work Session, we are excited to support the Ossining Children's Center re-location to State Street, and we look forward to seeing the project come along in the months ahead.
