II. BOARD RESOLUTIONS

A. Personnel: Reclassification of Title – Highway Department

Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining hereby reclassifies the title of Charles Bouton, Jr. from Automotive Mechanic Helper/Laborer to Automotive Mechanic effective February 8, 2021; and be it further

Resolved, that Mr. Bouton's salary remains at \$88,897 for the remainder of 2021.

Supervisor Levenberg said the following in regard to the resolution: Chuck has been working for the Town for over 10 years now, learning alongside our Lead Maintenance Mechanic, Gary Cecere, and as part of the Teamsters Contract that went into effect last year, Chuck received a promotion from his Auto Mechanic Helper/Laborer title to Auto Mechanic. It took quite a while to get the title sorted out with Civil Service, but we are glad to have him here "for the long haul" and grow in his position with the Town. The salary increase associated with his promotion already went into effect when the contract was settled, so we are just changing his title tonight.


At 7:34 P.M., Councilmember Feldman motioned to adjourn to the Town Hall Meeting and Councilmember Wilcher seconded.
