I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on March 9, 2021 via video conference, pursuant to Governor's Executive Order 202.1 dated March 12, 2020. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Jackie G. Shaw, Elizabeth R. Feldman, Northern Wilcher, Jr., and Gregory G. Meyer. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Victoria Cafarelli, and Deputy Town Clerk Martha C. Quituisaca.

II. ANNOUNCEMENTS

Supervisor Levenberg announced the following:

The CDC announced yesterday more guidance for vaccinated individuals, including relaxed recommendations when it comes to small, indoor gatherings. This is a giant step for many of our senior citizens and those who have been separated from loved ones for a year. Residents should keep in mind that in New York State, gatherings at private residences are still limited to 10 people indoors. Starting on March 22nd, the state will update its guidance to allow outdoor private events at up to 25 people and outdoor public events at up to 200. This is all very exciting. Of course, we do not know how this will impact summer camps, graduations, and other warm-weather traditions but we are coordinating with State and County officials to prepare for the future.

We also learned today that eligibility for vaccines has been expanded in New York to now include people over the age of 60. Appointments will begin opening up starting tomorrow, March 10. Additionally, public facing government employees, non-profit workers, and essential building service workers are eligible for the vaccine starting March 17. We are very grateful to hear this news as these additions to the eligibility criteria will apply for most Town staff members. All eligible individuals can be vaccinated at all sites except pharmacies, which are limited to those over 60 years old and teachers. Visit covid19vaccine.healthy.ny.gov to learn more and check your eligibility.

Over 150,000 people have been vaccinated in Westchester County, and nationwide, more individuals have now received at least one vaccine dose than the total number of people who have tested positive since the pandemic began one year ago. These are promising numbers!

Of course, despite these positive reports, the pandemic is still not over. Everyone still must wear a mask in public, limit non-essential travel, quarantine if exposed to a positive case, and get tested if you don't feel well. Testing is still readily available in Ossining. On Sunday, testing will be available at the Ossining Community Center, courtesy of Westchester Medical Center. You must make an appointment to receive a test. You can reserve a spot by calling 914-202-4530 or by visiting the Westchester Medical Center website, selecting their preferred language, and following the links for the Diagnostic Testing Appointment Request. The website lists the Ossining Rec Center as a Mobile Testing site.

On Saturday, the Village of Ossining will break ground on a memorial to victims of COVID-19. The ceremony will be shared on Facebook Live on the Town and Village account. The memorial will be a solemn place to remember the 2.6 million deaths around the world and 525,000 thousand lost in the United States. Nearly everyone has lost a member of their families or a close friend, and I will be joined by other elected officials on Saturday in their honor. The livestream will begin at 10am.

The Ossining community continues to come together and offer relief to each other. With the Johnson & Johnson vaccine arriving, the COVID Angels initiative is working hard to connect local senior residents with vaccines. If you know a senior who is struggling to navigate the registration process, please contact us at OTownVaccineAngels@gmail.com. A giant shout out to Joan Dengler for helping overseeing the day to day management of the initiative. We are so grateful for your commitment. Our COVID Angels volunteers help seniors navigate the frustrating process to find appointments for vaccines. They will even help seniors arrange for transportation if needed. We also learned this week that the Westchester County Paratransit program is providing rides for seniors and disabled constituents to vaccination appointments. Residents can call (914) 995-7272 to make a reservation. Reservations need to be made 24 hours in advance to allow for scheduling. Remember vaccines don't beat COVID, vaccinations do and we are truly all in this together.

Huge shout out to the Ossining Open Door, Ossining Volunteer Ambulance Corps, Town Senior Nutrition Program Staff, and many other volunteer organizations for helping to get dozens of people vaccinated this weekend at the State pop-up site in Ossining. The slots filled up very quickly with our hard to reach seniors, but hopefully more pop-ups will be coming to Ossining in the near future.

The Town is also putting together a list of homebound seniors, who may need vaccines to come to them. There are currently no mobile vaccination units in New York State, but we feel that this may change with the single-shot Johnson & Johnson vaccine. The Westchester County is offering an exam for people looking to become police officers. The Ossining Police Department has released a series of videos to help people learn how to sign up for the exam. If your internet access is limited, you can visit the police station lobby where they've set up an "application station." Sign-ups for the exam are allowed until the end of the month and the police department will be sharing reminders until then. If you are not interested in becoming a police officer, Westchester County offers a whole host of civil service exams for positions ranging from office work to engineering. The Town, along with all other municipalities, fire districts, and school districts, are required to hire off of these civil service lists for most positions. So please, visit humanresources.westchestergov.com to learn more about all civil service exams and positions open across the County.

Every Tuesday in March, the Ossining PTA is partnering with local businesses for their Take Out Tuesday fundraiser. The money raised will go to support the

senior class of 2021. What a great way to support our students and local entrepreneurs! Don't forget to mention the senior class of 2021 when you order. For a list of weekly businesses, visit the Ossining PTA Facebook page.

The Living Art Event kicked off last week in a virtual collaboration between the Westchester Collaborative Theater and the Ossining Arts Council. The 2021 LAE is dedicated to the memory of Joe Albert Lima, longtime WCT playwright, director, and actor who passed away last year. Lima was scheduled to direct the LAE in 2020. And finally, save the date for Thursday, April 8 from 7:30pm to 9pm for our next public workshop on the Comprehensive Plan. Zoom information is available on the project's website www.sustainableossining.com. At this meeting, we will be seeking community feedback on draft goals as we continue through this process. We ask that participants join via a computer to enhance their experience since this meeting will be interactive over Zoom. But if you do not have access to a computer, we are planning some non-virtual ways to contribute to this process this spring, so stay tuned.

Councilmember Feldman announced that Hudson Pharmacy on Spring ST will be distributing COVID-19 vaccines to people 60 years or older.

A. Approval of Minutes—Regular Meeting – February 23, 2021

Councilmember Shaw moved and it was seconded by Councilmember Wilcher that the following resolution be approved as amended.

Resolved, that the Town Board of the Town of Ossining hereby approves the February 23, 2021 minutes of the Regular Meeting as presented.

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining hereby approves the Voucher Detail Report dated March 9, 2021 in the amount of \$394,927.18

C. Resolution – Authorizing Levy of Unpaid Water Charges on Town Tax Roll

Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the following resolution be approved.

WHEREAS, pursuant to an Inter-Municipal Agreement (“Water IMA”) dated January 1, 2002, the Village of Ossining supplies water to the Unincorporated area of the Town of Ossining (“Town Outside”) and directly bills consumers in the Town Outside for water supplied pursuant to the Water IMA, and

WHEREAS, pursuant to the Water IMA, any water charge that is delinquent for three or more months shall be levied against the delinquent property by the Town and shall be subject to penalty in the manner provided by law, in which event, upon collection by the Town, the Town shall remit the amount collected to the Village of Ossining; and

WHEREAS, pursuant to Section 198 of the Town Law, the Town of Ossining is authorized to levy unpaid water charges against delinquent properties;

NOW, THEREFORE, BE IT RESOLVED, that any water charges to a customer outside of the Village of Ossining corporate limits and in the Town of Ossining that is delinquent for three or more months that has not submitted a certification in accordance with Chapter 108 amendment to Public Service Law shall be levied against the delinquent property and shall be subject to penalty in the manner provided by law,

AND BE IT FURTHER RESOLVED, that the Village Treasurer, on behalf of the Village Clerk of the Village of Ossining, shall file with the Supervisor of the Town of Ossining, as required by law, statements showing unpaid water charges to customers outside of the Village of Ossining corporate limits, but within the Town of Ossining, which are delinquent for three or more months and that such statements shall contain a brief description of the property upon which the water was used, the names of the persons or corporations liable to pay for the same and the amounts chargeable to each for the purposes of levy and enforcement under “Water Rents” and upon receipt of such statement, the Supervisor will transmit said statement of delinquent water charges to the Receiver of Taxes for levy against those delinquent properties.

Supervisor Levenberg said the following in regard to the resolution: Each year, the Town adopts a resolution to levy any unpaid water charges onto the Town tax roll. This year, some accounts have been kept off this list because they qualify for relief due to COVID-19.

D. Environmental Advisory Board Appointment

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Resolved, that the Town Board appoints David Margulis to the Town Environmental Advisory Board for a five year term to expire on December 31, 2025.

Supervisor Levenberg said the following in regard to the resolution: Tonight, we are very excited to be adding David Margulis to our Environmental Advisory Committee. David is a volunteer with the New York/New Jersey Trail conference and really brings so much to the table. We already have a standout EAC so with his appointment, we are actually increasing the number of members from five to six – the more volunteers to this advisory board, the merrier!

E. Contract – Removal of Snow and Ice from County Roads

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved as amended.

Resolved, that the Town Board of the Town of Ossining authorizes the Supervisor to sign an agreement with Westchester County Department of Public Works and Transportation for the Town to remove snow and ice from County roads within the Town’s jurisdiction and be compensated for the removal of snow and ice at the schedule of rates set forth in the contract and adjusted annually, for a five year term beginning October 1, 2020 and ending September 30, 2025.

Supervisor Levenberg said the following in regard to the resolution: There are several County roads in our jurisdiction, and in exchange for the Town removing snow and ice from these roadways during storms, the Town is compensated with a set amount per mile of roadway detailed in the contract. The amount changes annually in accordance with the County tax levy throughout the five year contract.

F. Contract – Positive Youth Development Program

Councilmember Feldman moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining authorizes the Supervisor to sign an agreement with Westchester County for the Ossining Recreation Department to provide a Positive Youth Development Program, the ZUMBA Kids Program, with the Town reimbursed at an amount not to exceed \$3,028.

Supervisor Levenberg said the following in regard to the resolution: The Town is the “pass through” for some funds relating to youth programming through the Ossining Recreation Program. Our Superintendent of Recreation Bill Garrison asked that the Town Board approve this contract for them to offer a ZUMBA Kids program with some reimbursement from the County for this program. Hopefully we will be seeing more ZUMA-ing and less Zoom-ing in 2021!


