I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular meeting of the Town Board of the Town of Ossining was held on July 11, 2023 at the Municipal Building, 16 Croton Ave, Ossining, NY 10562 AND via video conference. The meeting was called to order at 7:30 PM by Supervisor Elizabeth R. Feldman. Members of the Board present were: Councilmembers Gregory G. Meyer, Angelo A. III. DEPARTMENTAL REPORT

- Town Building Inspector Jon Turnquist spoke about new permits issued by the Town Building Department, small residential additions, the Triannual Fire Inspection, conversions from oil systems to gas systems, solar panels being added to homes, Storm Water Pond Restoration, and updating the Town Building Department to a new computer system.
- Town Treasurer Dale Brennan spoke about the sales of houses slowing down and as a result the first half mortgage revenue that came in June equaled 51% whereas in the past when it was 100%. Town expenses are up to 50% halfway through the year. The Town is keeping an eye out on the tax expenditure lines, as payments will be made on them on the voucher run for July 25, 2023 meeting. The Bond Market will be on July 20, 2023 this year.
