#### I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on June 14, 2011 in the Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Catherine Borgia. Members of the Board present were: Councilmembers Geoffrey Harter, Michael Tawil, Northern Wilcher and Peter Tripodi. Also present were Town Attorney Wayne Spector and Town Clerk Mary Ann Roberts.

#### II. ANNOUNCEMENTS

Supervisor Borgia announced that the Town and Village of Ossining held a joint meeting this evening at 16 Croton Avenue at 6 p.m. at which time two consultant groups provided a presentation on alternate government proposals. This Joint Meeting was televised. All four of the proposals are on the Town website for review. This is being funded by a Department of State High Efficiency Grant.

Congratulations on a wonderful job at the Village Fair. A wonderful time was had by all. The Atria on Hudson will hold their Grand Re-Opening on Tuesday, June 21, from 5:30 p.m. -7:30 p.m. with the ribbon cutting ceremony taking place at 6:30 p.m.

On June 30<sup>th</sup> at 5 p.m. the Ossining Fire Department will host their Annual Inspection at the Ossining Fire Headquarters, Senate Hook & Ladder Quarters on the second floor located at 21 State Street.

Supervisor Borgia reminded residents that Community That Cares is working with our Recreation Department to create some positive activities for our young people this summer.

The Boathouse received a good review in the Journal News this weekend.

#### E. Firework's Approval – St. Augustine's Church

Councilmember Tawil moved and it was seconded by Councilmember Wilcher that the following be approved:

Whereas, the Church of St. Augustine, by letter dated May 27, 2011 has requested a permit from the Town of Ossining for a fireworks display to be held on the evenings of July 20, 2011 (rain date of July 21, 2011) and July 24, 2011; and

Whereas, the Church has submitted the information required by Section 101-5 of the Code of the Town of Ossining and Section 405(2) of the Penal Law of the State of New York; and

Whereas, the bond/insurance coverage submitted by the Church has been found by the Town Attorney to comply with the requirements of Section 101-6 of the Ossining Code and Section 405 of the State Penal Law; and

Whereas, the Fire Chief has made an inspection of the premises where the fireworks display will be held and reported that such display will not be hazardous to persons or property;

Now, Therefore, Be It Resolved, that the application of the Church of St. Augustine's for a fireworks display on July 20, 2011 at 9:15 p.m. (rain date July 21, 2011, ) and July 24, 2011 at 9:15 p.m., is approved subject to the following conditions pursuant to Section 405(3) of the Penal Law:

- 1. The actual point at which the fireworks are to be fired shall be at least 200 feet from the nearest permanent building, public highway or railroad or other means of travel and at least 50 feet from the nearest above-ground telephone or telegraph line, tree or other overhead obstruction;
- 2. The audience at such display shall be restrained behind lines at least 150 feet from the point at which the fireworks are discharged and only persons in active charge of the display shall be allowed inside these lines:
- 3. All fireworks that fire a projectile shall be so set up that the Projectile will go into the air as nearly as possible in a vertical direction, unless such fireworks are to be fired from the shore or a lake or other large body of water, in which case they may be directed in such manner that the falling residue from the deflagration will fall into such lake or body of water;
- 4. Any fireworks that remain unfired after the display is concluded shall be immediately disposed of in a way safe for the particular type of fireworks remaining;
- 5. No fireworks display shall be held during any wind storm in which the wind reaches a velocity of more than 30 miles per hour;
- 6. All persons in actual charge of firing the fireworks shall be over the age of 18 years, competent and physically fit for the task;
- 7. There shall be at least 2 such operators consistently on duty during the discharge; and
- 8. At least 2 soda acid or other approved type fire extinguishers of at least 2 and one-half gallons capacity each shall be kept at as widely separated points as possible within the actual area of the display; and it is further

Resolved, that a copy of this Resolution duly certified by the Town Clerk of the Town of Ossining shall constitute a Permit, meeting the requirements of the Code of the Town of Ossining and the Penal Law of the State of New York.

RESOLVED, that the Town Supervisor is authorized to enter into an agreement with each individual former Town police officer who wishes to purchase a service revolver from the Town, after complying with all legal protocol associated with the purchase of firearms in Westchester County, upon the approval of the Town Attorney.
