I. CALL TO ORDER – PLEDGE OF ALLEGIANCE – ROLL CALL

The Special Meeting of the Town Board of the Town of Ossining was held on January 7, 2014, Municipal Building, 16 Croton Avenue, 1st Floor Board Room, Ossining, New York. The meeting was called to order at 8:00 p.m. by Supervisor Susanne Donnelly. Members of the Board present were: Councilmembers Eric Blaha, Kim L. Jeffrey, Geoffrey Harter and Northern Wilcher. Also present were Town Attorney Wayne Spector, Budget Officer Madeline Zachacz and Deputy Town Clerk Ann Marie Rocco.

II. RESOLUTIONS

A. Personnel – Appointment Assessment/Tax Aide

Councilmember Blaha moved and it was seconded by Councilmember Wilcher that the following be approved:

Resolved, that the Town Board of the Town of Ossining hereby appoints Blanca Perez, Ossining, to the full-time Provisional Probationary position of Assessment/ Tax Aide effective January 8th, 2014, at an annual salary of \$41,500.

B. <u>Finance – Capital Project #2011-2175 - Cedar Lane/Stormytown Road Water</u> <u>Mains</u>

Councilmember Wilcher moved and it was seconded by Councilmember Harter that the following be approved:

Resolved, that the Town Board of the Town of Ossining authorizes a 2013 budget adjustment to Capital Project #2011-2175, entitled "Cedar Lane/Stormytown Road Water Mains", in the amount of \$75,000, decreasing the project expenditure account and transferring the unexpended balance to debt service as appropriated surplus. Furthermore, the Water fund debt service revenue and expense accounts are increased \$75,000 for the appropriated surplus applied to the Bond Anticipation Note principal balance.

C. <u>Finance – Capital Project #2010-2172 – Old Albany "S" Curve</u>

Councilmember Harter moved and it was seconded by Councilmember Wilcher that the following be approved:

Resolved, that the Town Board of the Town of Ossining authorizes a 2013 budget adjustment to Capital Project #2010-2172, entitled "Old Albany S Curve", in the amount of \$33,643.79, decreasing the project expenditure account and transferring the unexpended balance to debt service as appropriated surplus. Furthermore, the Highway fund debt service revenue and expense accounts are increased \$33,643.79 for the appropriated surplus applied to the Bond Anticipation Note principal balance.
