III. RESOLUTIONS

A. 2015 Cabaret License for The Briarcliff Manor Featuring Antipasti di Napoli Restaurant & Bar

Councilmember Jeffrey moved and it was seconded by Councilmember Harter that the following be approved:

Whereas, The Briarcliff Manor Featuring Antipasti di Napoli Restaurant & Bar has filed an application for a Cabaret License for the calendar year 2015; and

Whereas, the Town Board has reviewed the application and attachments thereto, as well as reports from involved departments, including the Police Department and Building Department; now therefore be it

Resolved, that the Town Board of the Town of Ossining hereby approves the application of The Briarcliff Manor Featuring Antipasti di Napoli Restaurant & Bar, 25 Studio Hill Road, Briarcliff Manor, in the Unincorporated Area of the Town of Ossining, for a Cabaret License, subject to the following limitations and conditions: Recorded Music, Live Music for private parties shall be allowed on Thursday through Saturday from Noon through Midnight and Sunday through Wednesday from Noon through 11:00 p.m.

B. Tax Receiver - Property Redemption, Thornton Hill

Councilmember Blaha moved and it was seconded by Councilmember Jeffrey that the following be approved:

Whereas, properties located at Thornton Hill, Ossining, have delinquent taxes resulting in commencement of In Rem foreclosure proceedings and a judgment of foreclosure, and

Whereas, Nationstar, the mortgage holders, have requested to redeem the properties and have tendered full payment; and

Whereas, the Town Board desires to allow the mortgage holders of said property a window of opportunity to redeem the property prior to auction;

Now therefore be it Resolved, that the Town Board of the Town of Ossining hereby allows Nationstar, the mortgage holders of properties at Thornton Hill, Ossining, to redeem said properties by paying all outstanding taxes, interest, penalties and fees, plus an additional ten (10%) percent penalty on the lien amount, which, upon the recommendation of the Receiver of Taxes, the Town Board finds to be fair and appropriate based on the specific and unique circumstances of this case.
