I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Special Meeting of the Town Board of the Town of Ossining was held on March 19, 2018 in the Ossining Municipal Building 16 Croton Avenue-1st Floor Board Room in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Karen M. D'Attore, Elizabeth R. Feldman, Northern Wilcher Jr. and Jackie G. Shaw. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Madeline Zachacz and Deputy Town Clerk Ann Marie Rocco

Supervisor Levenberg asked to please remain standing while we observe a moment of silence for all those lost or injured in the tragic mosque shootings in Christchurch, New Zealand.

I wish these moments could add up to a solution to end gun violence worldwide. As we mourn the loss of innocent victims of hate crimes, we must continue to work together on solutions to reduce these incidents in whatever way we can at all levels of government.

Supervisor Levenberg stated that as Per the New York State and Local Retirement Systems, all employees that do not have a standard timekeeping system (for example, a set number of sick, personal, and vacation days) like elected officials, must keep a calendar of their activity for three months at the beginning of their terms so their time in service can be accurately reported to the retirement system. As our Tax Receiver Holly Perlowitz and Town Board Member Jackie Shaw fit in this category and recently started new terms, the Town Board must adopt their "Record of Activities" to be reported to the retirement system. This is a bit of a complicated process and formula, so thank you to Maddi Zachacz and Victoria Cafarelli in my office for coordinating this effort to get our elected officials reported correctly to the retirement system.
