I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on March 10, 2020 in the Birdsall-Fagan Police/Court Facility, 86-88 Spring Street in Ossining. The meeting was called to order at 7:30 p.m. by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Jackie G. Shaw, Elizabeth R. Feldman, Gregory G. Meyer, and Northern Wilcher Jr. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Victoria Cafarelli, and Town Deputy Clerk Martha C. Quituisaca.

II. ANNOUNCEMENTS

Supervisor Levenberg announced the following:

We are continuing to monitor Coronavirus cases in Westchester County and neighboring communities with the help of County officials and State and Federal agency guidelines.

Out of an abundance of caution, we have decided that effective Friday, March 13, the Senior Nutrition Program that operates out of the Joseph G. Caputo Community Center will transition to offering only home delivered meals. Congregate meals in the dining room and all other events and programming have been cancelled for the foreseeable future. Our program staff is working around the clock to notify all seniors and their families that will be impacted by this change so we can continue to offer quality and nutritious meals to our most vulnerable population during this uncertain time. If anyone has any questions about this change, please do not hesitate to contact the Senior Nutrition Program at (914) 762-1350.

We understand that people are very concerned about the health and safety of their loved ones and we encourage everyone to seek out information and updates from official sources to avoid inaccurate or out-of-date information. The New York State Department of Health has set up a hotline at 888-364-3065 with staff on standby to help answer questions regarding Coronavirus. Westchester County's 211 service is also activated and ready to answer questions. Additionally, we would like to remind everyone that vulnerable populations such as seniors are best protected when the people around them make healthy choices, including staying home if they believe they exhibit symptoms of any illness not just coronavirus. If you or a loved one needs medical attention and has any symptoms, coughing, trouble breathing, etc. call first before going to any urgent care facility or ER so they can give you proper direction to be seen in a secure area.

We'd like to remind everyone that there are simple steps we can all take to curb the spread of this virus and other seasonal illnesses like the flu. Be sure to wash your hands with soap and water for at least 20 seconds. The use of alcohol-based hand sanitizer can be used if soap and water are not available. Cough or sneeze into a tissue and throw the tissue in the trash. Try to avoid touching surfaces that others may have touched by either wearing rubber gloves or using an elbow. Avoid close contact with people who are sick. If you are sick, stay home. Avoid touching your eyes, nose, and mouth. Clean and disinfect frequently touched objects and surfaces, like your cell phone, door knobs, keyboards, computer mouse, using a cleaning product that contains bleach. These simple day to day actions can truly save lives.

We note Ossining Schools and Joseph Caputo Recreation Center remain open. We do not feel at this time there is any reason to close the buildings or cancel programs, however we will continue to provide information to the community.

Please be vigilant and stay tuned to our eblasts, nixles from our Police Department, messaging from the schools, county and state.

Also, there are many events across the County that are being cancelled right and left to prevent the spread of illness. Please check with event organizers ahead before attending in case of cancellation.

Kids ages 3-14 can be enrolled for fun activities like swimming, sports, and arts and crafts from the end of June to the beginning of August. Spaces are limited so visit the Village of Ossining Recreation online community catalog to sign-up.

The Greater Ossining Chamber of Commerce has two scheduled meetings this week. Stop by Tasty Table at 21 Campwoods Road for an 8am Meet & Greet tomorrow, Wednesday, March 11 for Ossining Business Owners. Business owners who are not available for an early morning event can visit Terra Rustica at 550 North State Road in Briarcliff on Thursday evening from 6 to 8 for a chance to meet other local business owners and discuss their strategies and ideas.

On Friday, March 13 you can stop by Maya Rivera at 518 North State Road for dinner and live music from the Mike Risko Band, who will be donating all earnings from the evening to the Ossining PTA. There is no cover for this event, but it's requested that you make a reservation to reserve your spot.

Saturday March 14th is the official 2nd Annual Chili Cook-Off Fundraiser at Sing Sing Kill Brewery. This year's fundraiser will support the Ossining under 11 travel baseball team as they raise money for a trip to Cooperstown, New York. The cook-off is from 4 to 7 and is 10 dollars per person or a great deal at 20 dollars per family.

Finally, 2020 Census Invitations will be arriving in the mail next week during the time period from March 12 through March 20! Keep an eye out in your mailbox for an invitation to respond to the 2020 Census online or via phone. All households are encouraged to respond through these methods upon receiving the invitation. Reminders will be sent out, and as a last resort, in-person Census takers will be knocking on doors in just a few weeks.

III. DEPARTMENTAL REPORTS

- Town Building Inspector John Hamilton provided the Town Board with an update of the Town Building Department's activities. The Town Building Department has given out 61 permits and has conducted 158 inspections since January. The SPCA has received its building permit and will begin

work soon. There are currently three projects that have been approved but have not applied for a permit. The Town Building Department is working towards setting up Simprocity.

- Superintendent of Recreation Bill Garrison discussed what the Recreation Department has been busy with in the past couple of months. Summer camp registration has begun. Most people are signing up online; a few are still applying via paper in person. Veronica Roche is the new Recreation Supervisor. She is charge of evening and Sunday programs. The Community Center is opened 7 days a week. We are working towards creating new programs for people of all ages. Family Zumba, a new Spring program, is being funded by the Westchester Youth Bureau. The Recreation Department has not cancelled any programs yet.

D. Calling for a Public Hearing in the matter of the 2020 Cabaret License Renewal for Club Fit

Councilmember Feldman moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining hereby calls for a Public Hearing to be held on Tuesday, March 24th, 2020 at 7:30 p.m. at the

Birdsall- Fagan Police/Court Facility located at 86-88 Spring Street, Ossining, NY 10562, in the matter of the 2020 Cabaret License for Club Fit, 584 North State Road Briarcliff Manor, NY 10510.

Supervisor Levenberg said the following in regard to the resolution: As we set this public hearing on the cabaret license for Club Fit, we would like to encourage any interested parties to please submit their comments in writing in advance of the meeting on March 24. E. Approval of Provisional 2020 Cabaret License – Maya Riviera Bar and Restaurant, 518 North State Road, Briarcliff Manor

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Whereas, Maya Riviera Bar and Restaurant (the “Applicant”) has filed an application for a Cabaret License for the calendar year 2020; and

Whereas, in 2018 the Applicant requested extended hours during which it could play amplified music from 12:00 midnight to 1:00 a.m. on Fridays and Saturdays, which request the Town Board granted on a three-month provisional basis and then for the remainder of the 2018 calendar year and the 2019 calendar year; and

Whereas, the 2020 cabaret license application again requests to play amplified music until 1:00 a.m. on Fridays and Saturdays and now additionally requests that the Town Board extend the hours during which the Applicant can play amplified music on Sundays through Thursdays from 11:00 p.m. to 1:00 a.m.; and

Whereas, the Town Board is authorized under Chapter 68 of the Town Code (Section 68-20(B)) to extend hours a cabaret may play amplified music beyond what is permitted in the Code where it deems it appropriate and consistent with the public safety and welfare; and

Whereas, the Town Board has reviewed the 2020 application and attachments thereto, and has solicited input from involved departments, including the Police Department and Building Department; and

Whereas, on February 25, 2020, the Town Board opened a duly-noticed public hearing on the subject cabaret application, at which time no members of the public appeared to speak on the application, and the public hearing was closed on February 25, 2020; and

Whereas, based upon the record before the Board on this application, the Board wishes to issue a provisional cabaret license extending the hours during which amplified music can be played on Sundays through Thursdays from 11:00 p.m. to 1:00 a.m. for a three-month period, after which three-month period the Town Board will revisit the application; and

Now therefore,

Be it Resolved, that the Town Board of the Town of Ossining hereby approves the application of the Maya Riviera Bar and Restaurant, 518 North State Road Briarcliff Manor, in the Unincorporated Area of the Town of Ossining, for a Cabaret License for a provisional three-month cabaret license, subject to the following limitations and conditions:

1. The music played on site will consist only of (a) a Mariachi Band consisting of 3-5 members using guitars and trumpets or (b) a DJ using a Karaoke Machine
2. Amplified music shall be allowed on Sunday through Thursday from 11:00 a.m. to 1:00 a.m. and Friday and Saturday from 11:00 a.m. to 1:00 a.m.

Be it Further Resolved, after the three-month provisional period, the Town Board shall hold another public hearing on this application at its May 26, 2020 meeting and either approve this license in its current form for the entirety of 2020 or make changes to the hours the Applicant is authorized to play amplified music on Sundays through Thursdays if the Town Board deems it appropriate based upon the information received at the public hearing; and

Be it further Resolved, that the Town Board finds that based upon the lack of complaints from the public or the Town's departments and the positive role the Applicant's establishment plays in the community that it is appropriate and consistent with the public safety and welfare to allow the Applicant to play amplified until 1:00 a.m. on Friday and Saturday nights, but reserves the right to revisit this determination in subsequent years and make any modifications to the hours during which amplified music is permitted that the Town Board deems necessary based upon the circumstances presented at that time, and

Be it further Resolved, the conditions on this provisional cabaret license are only for the 2020 calendar year and the Town Board reserves the right to modify, add to and/or eliminate any and all conditions when considering the Applicant's application for a cabaret license renewal for the 2021 calendar year in accordance with Chapter 68 of the Town Code.

Supervisor Levenberg said the following in regard to the resolution: This approval is a provisional approval, given Maya Riviera's request for extended times of operation this year. The provisional approval will allow the Town to monitor the impacts of this change, before making a permanent approval.

F. Request for Proposals – Comprehensive Plan

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining issues a Request for Proposals for a planning firm to complete a Comprehensive Plan with Sustainability Elements, with responses due back to the Town Supervisor's Office by 4:30pm on April 17, 2020.

Supervisor Levenberg said the following in regard to the resolution: We are very excited to be moving forward on the RFP for the Comprehensive Plan, with responses due back to the Supervisor's office in late April.

G. Fee Schedule – Non-Resident Dog Park Use

Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining adds the following fee to the Town of Ossining Fee Schedule:

Non-resident use of the Cedar Lane and Ryder Park Dog Parks: \$25, plus \$10 per each additional dog, up to three dogs

Supervisor Levenberg said the following in regard to the resolution: As was discussed at last week’s Work Session, we have codified the fee for non-resident use at the dog parks. This fee was in place for some years but will now be officially part of our fee schedule.

H. Shared Service Inter-Municipal Agreement: New York State DEC Grant for “Recycling App”

Councilmember Wilcher moved and it was seconded by Councilmember Feldman that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining authorizes the Supervisor to sign a shared services inter-municipal agreement with the City of New Rochelle, Town of Greenburgh, Town of Harrison, Town of Ossining, Village of Bronxville, Village of Elmsford, Village of Hastings on Hudson, Village of Irvington, Village of Mamaroneck, Village of Pelham, Village of Tarrytown, and Village of Tuckahoe for the purposes of receiving grant funds and performing associated administration to receive said funds from the New York State Department of Environmental Conservation to procure a shared “recycling app,” intended to improve recycling efforts of all participating municipalities.

Supervisor Levenberg said the following in regard to the resolution: We have been working with Sustainable Westchester on this project, offering our recycling and solid waste schedules online and through an app. This year, another community is joining in on this effort, requiring a new inter-municipal agreement.

Motion: Carried

I. Resolution – Authorizing Levy of Unpaid Water Charges on Town Tax Roll

Councilmember Wilcher moved and it was seconded by Councilmember Shaw that the following resolution be approved.

WHEREAS, pursuant to an Inter-Municipal Agreement (“Water IMA”) dated January 1, 2002, the Village of Ossining supplies water to the Unincorporated area of the Town of Ossining (“Town Outside”) and directly bills consumers in the Town Outside for water supplied pursuant to the Water IMA, and

WHEREAS, pursuant to the Water IMA, any water charge that is delinquent for three or more months shall be levied against the delinquent property by the Town and shall be subject to penalty in the manner provided by law, in which event, upon collection by the Town, the Town shall remit the amount collected to the Village of Ossining; and

WHEREAS, pursuant to Section 198 of the Town Law, the Town of Ossining is authorized to levy unpaid water charges against delinquent properties;

NOW, THEREFORE, BE IT RESOLVED, that any water charges to a customer outside of the Village of Ossining corporate limits and in the Town of Ossining that is delinquent for three or more months shall be levied against the delinquent property and shall be subject to penalty in the manner provided by law.

AND BE IT FURTHER RESOLVED, that the Village Treasurer, on behalf of the Village Clerk of the Village of Ossining, shall file with the Supervisor

of the Town of Ossining, as required by law, statements showing unpaid water charges to customers outside of the Village of Ossining corporate limits, but within the Town of Ossining, which are delinquent for three or more months and that such statements shall contain a brief description of the property upon which the water was used, the names of the persons or corporations liable to pay for the same and the amounts chargeable to each for the purposes of levy and enforcement under “Water Rents” and upon receipt of such statement, the Supervisor will transmit said statement of delinquent water charges to the Receiver of Taxes for levy against those delinquent properties.

Supervisor Levenberg said the following in regard to the resolution: On an annual basis, any unpaid water bills due to the Village are levied on the Town/County Bill on behalf of the Village. As our Tax Receiver prepares the warrant and bills for the upcoming Town and County taxes, we need to officially approve this resolution to collect these unpaid fees.

J. Tax Certiorari – William and Edward Baker vs. Town of Ossining

Councilmember Feldman moved and it was seconded by Councilmember Wilcher that the following resolution be approved.


