I. CALL TO ORDER-PLEDGE OF ALLEGIANCE-ROLL CALL

The Regular Meeting of the Town Board of the Town of Ossining was held on September 13, 2022 via video conference, pursuant to Chapter 417 of the Laws of 2021 signed into law on September 2, 2021 by Governor Hochul and Executive Order 11.9. The meeting was called to order at 7:30 PM by Supervisor Dana A. Levenberg. Members of the Board present were: Councilmembers Elizabeth R. Feldman, Greg Meyer, Jennifer Fields-Tawil, and Angelo A. Manicchio. Also present were Town Counsel Christie Tomm-Addona, Budget Officer Victoria Cafarelli, and Deputy Town Clerk Martha C. Quituisaca.

II. PUBLIC HEARING

• Local law regulating bicycles, bicycles with electric assist and electric

At 7:31 PM, the Public Hearing opened.

Supervisor Levenberg said the following: Tonight, we have two public hearings on our agenda. The first is the continuation of a public hearing on a local law we introduced a few weeks ago. We are still hoping to connect with some of the Village of Ossining's consultants on this law, but the work of these consultants is hopefully on pause as we await news on the NYSERDA \$7million mobility prize challenge. Fingers crossed we'll get good news on that soon, and we can revisit the conversation about this local law. If we do not have any public comment, I would like to ask for a motion to adjourn this public hearing. We will renotice this when we are ready to bring it back.

At 7:33 PM, Councilmember Meyer moved and it was seconded by Councilmember Manicchio to adjourn the public hearing.

• Local law to amend the Zoning Code to establish a special permit use for artist communities

At 7:33 PM, the Public Hearing opened.

Supervisor Levenberg said the following: We are opening the public hearing tonight on a proposed local law to establish a special permit use for artist communities. We discussed this legislation at a work session in August. After we open this for public comment, we will be adjourning this local law to (ask Christie) while we await feedback from the County Planning Board.

Town Counsel Tomm-Addona discussed the timeline of the local law.

At 7:35 PM, Councilmember Meyer moved and it was seconded by Councilmember Manicchio to adjourn the public hearing to October 11, 2022.

Supervisor Levenberg said the following:

We are progressing in our application for a New York Forward grant. For those who are unaware, the New York Forward program is very similar to the Downtown Revitalization Initiative that the Village of Ossining won in the last round, but is scaled down to meet the needs of communities without large downtowns. After discussing with our grant writer and Town Planner, we have decided to put our hat in the ring for the Executive Boulevard/Stormytown Road area. We will be seeking public input on our application during an upcoming Town Hall meeting on Tuesday, September 20 at 7:30 PM. I hope you will join us to learn more and share your input revitalizing that area of Ossining can help support economic development in the entire community.

D. <u>A RESOLUTION AUTHORIZING THIRD PARTY PLAN REVIEW AND</u> <u>INSPECTION FOR RESIDENTIAL AND COMMERCIAL BUILDINGS</u> <u>FOR THE TOWN OF OSSINING</u>

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved.

WHEREAS, New York State has adopted the 2018 International Building Code family of codes with amendments, named 2020 Codes of NYS, as the guiding principle pertaining to residential and commercial construction and development within the state; and

WHEREAS, the Town of Ossining realizes that to promote public safety and preserve the quality and value of property within the community, coordinated development review processes are essential to ensuring that the adopted, nationally-recognized building codes and best practices are incorporated into buildings and structures; and

WHEREAS, third party plan review and inspection services will only be for the Energy Conservation Construction Code of New York State (ECCCNYS) or NYStretch compliance review; review by other departments in the Town of Ossining will still be required; and

WHEREAS, the Town Board deems it in the best interest of the citizens of the Town of Ossining to authorize the Building Inspector to allow third party plan review for residential and commercial buildings in the Town; and

WHEREAS, time of performance and terms of service are negotiated solely between the permit applicant and third-party plan review and inspection services provider; and

WHEREAS, it shall be the permit applicant's responsibility to ensure the third-party plan review and inspection services provider receives all the necessary construction documents and list of municipal requirements; approved stamped documents shall be submitted to the Building Department prior to the issuance of a building permit; and

NOW, THEREFORE

BE IT RESOLVED, that the Town Board hereby makes the following findings and determination:

1. The findings and recitations set out in the preamble to this Resolution are found to be true and correct and are hereby adopted by the Town Board and made a part of hereof for all purposes.

2. The Town Board hereby authorizes the Building Inspector to allow third party plan review and inspection for compliance with the ECCCNYS and NYStretch.

3. This Resolution shall be and become effective from and after the date of its adoption.

Supervisor Levenberg said the following: The Town of Ossining is participating in a pilot program with NYSERDA to offer third party plan review for building permit applications in an effort to increase and ease compliance with the NY Stretch Energy Code. This pilot program is associated with some grant funds, which we are grateful for and can't wait to apply to an exciting green project in the future!

E. <u>Resolution in SUPPORT OF Assembly Bill A-9079/Senate Bill S8378</u> <u>Amending Environmental Conservation Law by Adding New Section 24-</u> <u>0513, Local Freshwater Wetlands Pesticide Prohibition</u>

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved.

WHEREAS, New York State Assembly Bill A-9079 sponsored by Assemblymember Chris Burdick and by State Senator Peter Harckham in the State Senate seeks to amend the Environmental Conservation Law to restore certain home rule rights to local governments; and

WHEREAS, the legislation states as follows:

A local government that has implemented a freshwater wetlands protection law or ordinance in accordance with section 24-0501 of this title may adopt a local law or ordinance to prohibit the application of pesticides to wetlands it regulates; provided, however, that any such law or ordinance shall not prohibit pesticide applications for the control of invasive species identified pursuant to title 17 of article 9 of this chapter, pests of significant public health importance, noxious weeds designated by the department as injurious to ecosystem health, or for the protection of critical native plant species. Any local law or ordinance adopted pursuant to this section shall take effect on the first day of January after it shall have been adopted, and

WHEREAS, wetlands protection is critical to the Town of Ossining to protect drinking water and to provide flood plains protection.

Now THEREFORE, BE IT RESOLVED BY the Town of Ossining

1. That the Town Board does hereby support Bill Number A9079/S8378

2. The Town Board urges Governor Kathy Hochul to sign this critical legislation.

3. That a copy of this resolution be sent to the Office of the Governor, Senator Harckham, Assemblymember Burdick, Senate Majority Leader Andrea Stewart Cousins, Assembly Speaker Carl Heastie, County Executive George Latimer, Sustainable Westchester and the Westchester Municipal Officials Association.

Supervisor Levenberg said the following: Thank you to Assemblymember Chris Burdick for joining our meeting last week to give us some background on this legislation. We are happy to offer our support as a Board and urge the Governor to sign this legislation so local governments can implement increased wetlands protections at their individual discretion. F. Call for Public Hearing – Local law regarding Restoration of Town Roads

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved as amended.

Resolved, that the Town Board of the Town of Ossining hereby calls for a Public Hearing to be held in the matter of a Local law regarding Restoration of Town Roads on Tuesday, September 27, 2022 at 7:30 p.m. at the Municipal Building 1st Floor Conference Room, 16 Croton Ave, Ossining, NY 10562.

Supervisor Levenberg said the following: At our last work session, we heard from our Town Highway Superintendent about how having legislation on the books regarding road restoration would be helpful when outside utilities, like Con Ed, come and do work on our Town roads. We are modeling our legislation off of the Village of Briarcliff, and we look forward to hearing from the public at our next legislative session on the topic.

Motion: Carried Unanimously

G. <u>Resolution supporting the Clean Water, Clean Air, Green Jobs</u> <u>Environmental Bond Act of 2022</u>

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved.

Whereas, providing clean drinking water and protecting our local rivers, bays, lakes, streams and waterfronts from pollution is paramount to quality of life in New York State and the Town of Ossining; and

Whereas, modernizing water infrastructure will safeguard clean water, reduce flooding, reduce lead exposure and other public health threats, and create jobs; and

Whereas, the Town of Ossining is vulnerable to extreme weather including deadly heat from rising temperatures and flooding from severe storms that put people, properties and public assets across the Town at risk; and

Whereas, upgrading transportation and stormwater infrastructure, restoring natural resources, growing urban forests, building green roofs and upgrading cooling centers will reduce the impact of extreme weather, saving lives and money; and

Whereas, the COVID-19 pandemic demonstrated the importance of outdoor recreation and access to fresh, local food, as people flocked to local parks and sought out healthy foods for their families; and

Whereas, upgrades to facilities at state and local parks and preserves and the creation of new outdoor recreational areas will benefit our region by protecting wildlife habitat, providing more people access to nature, and creating jobs in the outdoor recreation economy; and

Whereas, the Clean Water, Clean Air, Green Jobs Environmental Bond Act of 2022 would authorize the four billion and two hundred million dollars of bonds to finance critical environmental restoration, clean water, and infrastructure projects across New York State; and Whereas, the funds would be targeted towards protecting clean water, reducing flood risk, restoring natural resources, protecting open space and farmland, and reducing the pollution that causes climate change; and

Whereas, the Clean Water, Clean Air, Green Jobs Environmental Bond Act of 2022 was passed by the New York State Legislature as part of the 2022-23 New York State Budget and will appear on the November 8, 2022, New York State General Election Ballot for voter approval; and

Whereas, the Clean Water, Clean Air, Green Jobs Environmental Bond Act of 2022 includes strong labor provisions and will support more than 84,000 family-sustaining jobs for New Yorkers; and

Whereas, the Clean Water, Clean Air, Green Jobs Environmental Bond Act of 2022 would enable New York State and the Town of Ossining to address pollution and public health threats in disadvantaged communities by directing at least 35% with a goal of 40% of the measure's funding to address hazardous conditions in such communities; now, therefore, be it

Resolved, that the Town Board of the Town of Ossining supports passage of the Clean Water, Clean Air, Green Jobs Environmental Bond Act of 2022.

Supervisor Levenberg said the following: Thank you, Suzie, for reminding us why this is so important. Remember to flip your ballot this November!

H. Proposal Renewal – Millennium Strategies LLC

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved.

Resolved, that the Town Board of the Town of Ossining hereby accepts the proposal of Millennium Strategies LLC, Nanuet, NY 10954 for 12 months of grant writing services through August 2023, at a monthly fee of \$3,000.

Supervisor Levenberg said the following: Millennium Strategies has been working for the Town for a year now on our grant applications. We are happy with their work thus far, which has secured us upwards of \$100,000 in grant funds just in one year. Hopefully we can double, or triple, or maybe even quadruple that amount in the next year with their help!

Councilmember Feldman moved and it was seconded by Councilmember Meyer that the following resolution be approved.

Whereas, the Town of Ossining is required to collect Town, County and School taxes for the municipality, with the onus on the Town to make whole the County and School District for any uncollected taxes; and

Whereas, the Receiver of Taxes has been approached by a property owner requesting a short-term payment plan for the property at 1-02 Briarcliff Drive South, Tax Parcel Designation ID# 80.19-1-16./102; and

Whereas, the Town Board, pursuant to Article 5 of the Ossining Town Code, as authorized by section 1184 of the New York Real Property Tax Law, before entry of a final judgment, may withdraw a parcel for which payment of real property taxes is delinquent, from a foreclosure proceeding and enter into an installment plan for payment of all delinquent taxes, as well as interest and penalties, and does occasionally grant such a plan and has the discretion to accept or reject any proposal by a residential property owner, providing the owner meets the eligibility requirements set forth in section 180-17 of the Town Code and the payment plan conforms to the requirements for such a repayment plan set forth in section 180-18 of the Town Code;

Now, therefore be it Resolved, that the Town Board of the Town of Ossining hereby grants the aforementioned payment plan, which terms comply with the Town Code, to this property owner, who has been determined to be eligible, with the understanding that this sets no precedent going forward for this or any other property in the future.

Supervisor Levenberg said the following: We are so grateful to our Tax Receiver, Holly Perlowitz, for coming to the Board to seek solutions like tax payment plans to ensure that property owners can maintain their ownership, while paying off taxes and fees owed to the Town.

Whereas, the Receiver of Taxes has been approached by a property owner requesting a short-term payment plan for the property at 6-04 Brooke Club Drive, Tax Parcel Designation ID# 80.19-1-35./604; and

Whereas, the Town Board, pursuant to Article 5 of the Ossining Town Code, as authorized by section 1184 of the New York Real Property Tax Law, before entry of a final judgment, may withdraw a parcel for which payment of real property taxes is delinquent, from a foreclosure proceeding and enter into an installment plan for payment of all delinquent taxes, as well as interest and penalties, and does occasionally grant such a plan and has the discretion to accept or reject any proposal by a residential property owner, providing the owner meets the eligibility requirements set forth in section 180-17 of the Town Code and the payment plan conforms to the requirements for such a repayment plan set forth in section 180-18 of the Town Code;

Whereas, the Town Board, pursuant to Article 5 of the Ossining Town Code, as authorized by section 1184 of the New York Real Property Tax Law, before entry of a final judgment, may withdraw a parcel for which payment of real property taxes is delinquent, from a foreclosure proceeding and enter into an installment plan for payment of all delinquent taxes, as well as interest and penalties, and does occasionally grant such a plan and has the discretion to accept or reject any proposal by a residential property owner, providing the owner meets the eligibility requirements set forth in section 180-17 of the Town Code and the payment plan conforms to the requirements for such a repayment plan set forth in section 180-18 of the Town Code;

Now, therefore be it Resolved, that the Town Board of the Town of Ossining hereby grants the aforementioned payment plan, which terms comply with the Town Code, to this property owner, who has been determined to be eligible, with the understanding that this sets no precedent going forward for this or any other property in the future.
